AN ORDINANCE 2019-03-21-0227

AUTHORIZING THE APPLICATION AND ACCEPTANCE, TEXAS DEPARTMENT AWARDED, OF \mathbf{A} TRANSPORTATION "CLICK IT OR TICKET" **ENFORCEMENT** SELECTIVE TRAFFIC **PROGRAM** GRANT FOR THE PERIOD OF MAY 20, 2019 THROUGH JUNE 2, 2019.

WHEREAS, the Texas Department of Transportation (TxDOT) has a "Click It or Ticket" Comprehensive Selective Traffic Enforcement Program (STEP) Grant for the period of May 20, 2019 through June 2, 2019; and

WHEREAS, grant consists of \$40,000.00 from TxDOT, will fund overtime with goal of increasing seatbelt use in motor vehicles, along with public information and education; and

WHEREAS, this will be the eighteenth year TxDOT has offered this grant to the San Antonio Police Department; and

WHEREAS, this grant does not require a city match and will not impact the City's General Fund, NOW **THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the San Antonio Chief of Police or designee, is hereby authorized to apply for and accept funds in an amount up to \$40,000.00 from TxDOT for the 2019 "Click It or Ticket" STEP grant for the period beginning May 20 through June 2, 2019. A copy of the application will be on file with the San Antonio Police Department.

SECTION 2. Should funding be awarded, upon acceptance of this award, new funds and internal order numbers will be created, upon which the award amount will be appropriated from TxDOT. A final budget, which will include SAP Internal Orders and SAP GL Accounts, will be submitted by the San Antonio Police Department.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
