The City Council convened in a Regular Meeting. Deputy City Clerk Leticia Saenz took the Roll Call noting the following Councilmembers present:

Ms. Saenz announced that Councilmember Shaw was attending the meeting via videoconference.

1. The Invocation was delivered by Dr. Ernesto Garza, Deacon, St. Matthew Catholic Church, guest of Councilmember Manny Pelaez, District 8.
2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes for the Regular City Council Meetings of August 9 - 10, 2017.

Councilmember Viagran moved to approve the minutes for the Regular City Council Meetings of August 9-10, 2017. Councilmember Treviño seconded the motion. The motion

prevailed by the following vote:

Councilmember Treviño asked of the change that was necessary. Peter Zanoni stated that the grant amount from the San Antonio Housing Trust for the Under 1 Roof Program had increased from \$500,000 to \$1.25 million.

Mayor Nirenberg called upon Mr. Jack F. Finger to speak.

Jack M. Finger expressed concern that funding for the Under 1 Roof Program would be utilized in Districts 1-5 noting that those Councilmembers serve on the San Antonio Housing Trust.

Councilmember Treviño moved to adopt the Ordinance for Item 11 in the amount of \$1.25 million for the Under 1 Roof Program and \$250,000 for the Minor Home Repair Program. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

**POINT OF PERSONAL PRIVILEGE**

Mayor Nirenberg recognized students from the Trinity University Fulbright Scholar Program and welcomed them to San Antonio.

**ACTION ITEMS FOR STAFF BRIEFING**

Deputy City Clerk Saenz read the caption for Item 4A:

4. Consideration of the following ordinances related to the Fiscal Year 2018 Operating and Capital Budget and Tax Year 2017: [Sheryl Sculley, City Manager; Justina Tate, Director, Management and Budget]

- 4A. An Ordinance adopting the Annual Consolidated Operating and Capital Budgets for the City of San Antonio Fiscal Year 2018 that begins October 1; approving projects included in the FY 2018 to FY 2022 Five-Year Infrastructure Management Plan; approving the FY 2018 to FY 2023 Six-Year Capital Improvements Program for the City of San Antonio; approving certain contracts; providing for a one-time annuity increase for retirees and their beneficiaries and a revision to the City's contribution rate in connection with the Texas Municipal Retirement System; authorizing personnel complements; appropriating funds; and amending related ordinances.

Sheryl Sculley presented an overview of the Proposed Budget for FY 2018 and stated that the budget addresses the City Council and Community Priorities. She reported that the budget was financially strong and totaled \$2.7 billion. She highlighted the \$3.5 million identified in the General Fund for 13 Amendments; \$500,000 in Restricted Funds for two Amendments; and \$7.6 million in the Capital Budget for nine Amendments.

Mayor Nirenberg called upon the citizens registered to speak.

Eddie Romero representing Centro San Antonio spoke in support of the FY 2018 Budget as proposed.

Sophie Torres representing the San Antonio Hispanic Chamber of Commerce spoke in support of the proposed FY 2018 Budget.

Gary Chance representing Haven for Hope spoke in support of the FY 2018 Budget that

included funding for Haven for Hope.

Jack M. Finger spoke in opposition to the proposed budget noting that property values had increased. He stated opposition for an Immigration Community Liaison and Homeless Encampment Outreach.

Mayor Nirenberg stated that he was proud of the budget presented which would help address some of the socioeconomic inequities that have existed for so long. He thanked staff for their work and all of the citizens that participated in the process.

Councilmember Saldaña expressed his support for the budget and the funding to address transportation. He spoke of the work in partnership with VIA Metropolitan Transit to modernize the bus system and recognized former Councilmember Ray Lopez for his efforts on transportation.

Councilmember Treviño expressed support for the budget and spoke of the great partnerships to include Centro San Antonio. He noted that equity funding would provide monies in areas of greatest need and was pleased with the funds allocated for the Under 1 Roof Program, Alley Maintenance, and Tree Planting.

Councilmember Gonzales expressed support for the equity-based budget and highlighted funding for Project Quest, Liftfund, Housing, Child Abuse, Drainage, Alleys, and increasing the City's Entry Level Wage. She noted funding for Public Safety, Street Maintenance, and addressing the need for multi-modal transportation.

Councilmember Viagran thanked staff for their work and the residents that participated in the budget process. She spoke in support of the budget and fund amendments for Public Safety, Street Maintenance, Code Enforcement, Park Police, Homeless Encampment Outreach, and the Liftfund. She noted that she was pleased with the equity distribution in the budget. She stated that she would work on property tax relief so that legacy homeowners are not dislocated by increasing property values.

Councilmember Brockhouse stated that the budget was a solid document and he was supportive of some of the items but noted concerns with the use of an equity lens for allocating funds. He expressed concern that his budget amendment for property acquisition was removed from the list noting that he did not believe that a majority of Councilmembers had expressed support for same. He stated that the budget process was flawed and he was not supportive of the amendment for addressing downtown glass sidewalks.

Councilmember Brockhouse moved to approve the FY 2018 Budget with the list of budget amendments submitted by the City Manager on September 12, 2017. Councilmember Perry

seconded the motion.

Councilmember Pelaez thanked everyone that participated in the budget process and stated that the budget was a strategic management tool that communicates priorities to the community. He noted that although not everyone received the same amount of funding in each district; the process and priorities may change next year.

Councilmember Courage stated that he understood the predicament of Councilmember Brockhouse and recognized his long-term plan for acquiring property. He stated the money could be better spent at this time and pledged to work on identifying funds for the property acquisition during the mid-year budget adjustment.

Councilmember Shaw thanked city staff for their work and stated that he was pleased with the equity distribution for street maintenance. He highlighted the funding for VIA and the Under 1 Roof Program that allows homeowners remain in their homes. He stated that he was supportive of small, minority, women-owned businesses.

Councilmember Perry spoke of the budget process and improvements that can be made but commended city staff for their work. He stated that there was a need for meaningful property tax relief and it must start somewhere.

Councilmember Sandoval thanked staff for their work and expressed support for the public safety improvements to include additional Park Police. She stated that she was pleased with the equity distribution of funds for the Under 1 Roof Program, Project Quest, Liftfund, and VIA. She commended Councilmember Saldaña for his efforts to secure funding for VIA and thanked Mayor Nirenberg for including funding for Climate Action. She pledged to work with Councilmember Brockhouse to identify funding for his request during the mid-year budget adjustment.

Councilmember Courage thanked members of the community for their participation in the budget process. He stated that he was pleased with the additional Police and Fire Personnel included in the budget, as well as funding for transportation, parks, and libraries.

Mayor Nirenberg spoke of the crisis regarding lack of public trust across the world and stated that he has been a champion of ensuring process and transparency. He noted that no matter what district a citizen lives in; this budget speaks to everyone. He added that he was pleased that they were placing the resources where they were needed most.

The motion by Councilmember Brockhouse to approve the FY 2018 Budget with the list of budget amendments submitted by the City Manager on September 12, 2017 failed by the following vote:

Councilmember Saldaña moved to ratify the adoption of the budget. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

Deputy City Clerk Saenz read the caption for Item 4C:

**4C.** An Ordinance setting the Ad Valorem Tax Rate for Maintenance and Operation of the City of San Antonio at 34.677 cents per \$100.00 of taxable valuation for the Tax Year beginning on January 1, 2017, and ending on December 31, 2017.

Councilmember Brockhouse stated that he wanted to provide property tax relief for citizens and recognized Bexar County for reducing their property tax rate.

Councilmember Brockhouse moved to amend the ad valorem tax rate from 34.677 cents per \$100 of taxable valuation to 34.177 cents per \$100 of taxable valuation for the tax year beginning January 1, 2017 and ending on December 31, 2017 and to reconsider Items

4A and 4B. Councilmember Perry seconded the motion.

Councilmember Courage commended Councilmember Brockhouse for wanting to provide property tax relief but stated that there should be a long-term discussion regarding same. He added that he would like to discuss increasing or creating a homestead exemption for taxpayers in the future.

Councilmember Pelaez stated that the property tax issue should be addressed at the State Level and noted the services that would have to be cut if the tax rate was reduced. Councilmember Treviño stated that the Chief Appraiser for the Bexar County Appraisal District would present to the City Council at an upcoming B Session.

Councilmember Perry stated that he was supportive of property tax relief and would be willing to forego his budget amendment request for a traffic intersection improvement to reduce the tax rate.

Councilmember Saldaña stated that it was important to have a balanced discussion on the tax rate and highlighted San Antonio's rate of 4.5% compared to other Texas Cities. Councilmember Gonzales expressed concern that the budget cuts recommended by Councilmember Brockhouse were related to long-term sustainability which benefits the city.

Councilmember Viagran commended Councilmember Gonzales for her work on the equity distribution. She stated that it was important to make effective tax changes for those who are hit the hardest. Councilmember Shaw stated that making property tax changes was a long-term discussion and expressed concern with the cuts that would have to be made if the rate was reduced. Councilmember Sandoval added that she concurred with Councilmember Shaw regarding the longer discussion that must be had regarding property taxes and the reduction in services.

Mayor Nirenberg commended Councilmember Gonzales for her role in helping the City Council refocus priorities to address issues of inequity. He stated that the City Council had reduced the tax rate seven times over the last 25 years and would be working with the legislature on future property tax relief.

The motion by Councilmember Brockhouse to amend the ad valorem tax rate to 34.177 cents per \$100 of taxable valuation and reconsider Items 4A and 4B failed by the following vote:

Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Councilmember Saldaña moved that taxes be increased by the adoption of a Debt Service Tax Rate of 21.150 cents per \$100 of taxable valuation, which is effectively a 4.56 percent increase in the tax rate. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:
