

AN ORDINANCE 2018-03-29-0206

**AUTHORIZING SUBMISSION OF A LOCAL CONTRIBUTION IN THE AMOUNT OF \$30,180.00 TO THE OFFICE OF THE TEXAS GOVERNOR IN ANTICIPATION OF REIMBURSEMENT OF UP TO \$218,800.00 FROM THE STATE EVENTS TRUST FUND FOR THE 2018 U.S. ARMY ALL-AMERICAN BOWL HELD AT THE ALAMODOME, APPROPRIATING FUNDS IN THE AMOUNT OF \$30,180.00 FROM THE CITY'S STATE REIMBURSEMENT FUND AND AUTHORIZING THE REIMBURSEMENT OF UP TO \$134,150.00 OF SPORTSLINK - THE GAME, LLC'S EVENT EXPENSES.**

**WHEREAS**, the 2018 Army All-America Bowl ("Event") was held at the Alamdome on January 6, 2018, attracted over 26,576 visitors from outside the San Antonio region and the Event was approved by the Governor's Office as eligible under the Events Trust Fund Program ("Program") for reimbursement of up to \$218,800.00 in qualified expenses related to hosting the Event; and

**WHEREAS**, as an element of the execution of the 2015-2020 U.S. Army All-American Bowl Multi-Year Lease Agreement with Sportslink- The Game, LLC ("Sportslink"), the City purchased AstroTurf Game Day Grass in the aggregate amount of \$125,000, with the intention that such cost be offset by a recovery from the Events Trust Fund and the outstanding Turf Recovery Fee balance is \$54,470.00; and

**WHEREAS**, the Program legislation (Vernon's Texas Civil Statutes, 5190.14) provides municipalities, counties and local organizing committees the opportunity to obtain reimbursement for eligible expenses related to hosting and attracting high-visibility, high-tax-impact events to the state of Texas, that could otherwise take place outside of the state, and reimbursements are based on the anticipated tax gain for a particular event and require municipalities to match funds that are deposited in the Program at a 1:6.25 ratio; and

**WHEREAS**, the City submitted an application to the Governor's Office for the Event and based on the sum of the eligible expenses, the statute requires the City to remit a local contribution of \$30,180.00 to the State representing the City's mandatory contribution to the Program and once the City's contribution is received and the Event takes place, the State will deposit 6.25 times the City's contribution into the Program and the City may then request disbursement from the Program for allowable Event expenses; and

**WHEREAS**, this Ordinance authorizes the City's local contribution, appropriates the necessary funds to pay the local contribution and authorizes reimbursement of up to \$134,150.00 of Sportslink's Event expenses from the Program after the City is reimbursed for its local contribution and the remaining Turf Recovery Fee; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Funding for this Ordinance in the amount of \$30,180.00 is available in Fund 29002001, Cost Center 8003020001 General Ledger 5407560 as part of the Fiscal Year 2018 Budget.


**SECTION 2.** Payment not to exceed the budgeted amount is authorized to Office of the Texas Governor and shall be encumbered with a purchase order.

**SECTION 3.** Funds are authorized to be received from Events Trust Fund for the 2018 U.S. Army All-American Bowl and upon receipt of the reimbursement from the State, those funds will be deposited back into the CSF State Reimbursement Fund, and the Turf Recovery Fee will be deposited into the Community and Visitor Facilities Fund, and Sportslink will receive payment for any remaining reimbursement awarded.


**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance shall take effect immediately upon the receipt of eight affirmative votes; otherwise it shall be effective ten days after its passage.
