WHEREAS, City staff submitted a grant application in an amount up to \$10,000.00 to the Texas Forest Service (TFS) for funds to be used in the development of a Community Wildfire Protection Plan; and

WHEREAS, no City matching contribution is required; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The actions of City staff in submitting a grant application in an amount up to \$10,000.00 to the TFS for funds to be used in the development of a Community Wildfire Protection Plan are hereby ratified.

SECTION 2. The City Manager and her designee are hereby authorized to accept said grant, if awarded under the same terms and conditions as applied for. The City Manager and her designee are further authorized to execute any and all documents necessary to effectuate said acceptance.

SECTION 3. Should an award be granted, upon acceptance of the award, new funds and internal order numbers will be created, upon which the award will be appropriated in an amount up to \$10,000.00 from the TFS.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
