# AN ORDINANCE 2015 - 01 - 29 - 006 8

SUBMISSION OF A GRANT AUTHORIZING THE APPLICATION FOR UP TO \$250,000.00 TO THE OFFICE **EMERGENCY TEXAS** DIVISION OF OF THE **EMERGENCY MANAGEMENT** FOR A 2015 MANAGEMENT PREPAREDNESS GRANT TO BE USED TO PREVENT, RESPOND TO, AND RECOVER FROM ACTS OF TERRORISM AND NATURAL DISASTERS; **MATCHING AUTHORIZING** IN-KIND AN\$250,000.00; AND CONTRIBUTION OF UP TO AUTHORIZING THE ACCEPTANCE OF FUNDS, UPON AWARD OF THE GRANT.

WHEREAS, the Office of Texas Division of Emergency Management (TDEM) has grant funds of as much as \$250,000.00 available from the 2015 Emergency Management Preparedness Grant (EMPG) Program; and

WHEREAS, the purpose of the 2015 EMPG Program is to enhance the ability of governments to prevent, respond to, and recover from acts of terrorism and natural disasters; and

WHEREAS, the grant application includes a request for funding of three personnel positions; and

**WHEREAS**, an award of EMPG funds would require an in-kind City contribution of as much as \$250,000.00; **NOW THEREFORE**:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1**. The City Manager and her designee are hereby authorized to submit a grant application in an amount not to exceed to \$250,000.00 to the 2015 EMPG Program for grant funds from the TDEM to assist the City in preventing, responding to, and recovering from acts of terrorism and natural disasters. The City Manager and her designee are hereby authorized to accept said grant, if awarded under substantially the same terms and conditions as applied for. The City Manager and her designee are further authorized to execute any and all documents necessary to effectuate said application and acceptance.

**SECTION 2.** An in-kind contribution of as much as \$250,000.00 is hereby authorized in the event of an award of EMPG Program funds. The personnel complement of two employees set out in **Exhibit I** is hereby approved.

**SECTION 3.** Fund 2606520026 is hereby designated for use in the accounting for the fiscal transaction in the acceptance of this grant. Should funding be awarded, the sum of up to \$250,000.00 from the TDEM will be appropriated in said fund.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

#### Attachment A: 2015 EMPG Grant Ordinance

## **OEM GRANT POSITION DESCRIPTIONS:**

The following 2 positions have been approved by the State as authorized grant-funded positions:

- **Department Fiscal Administrator** (826) Under administrative direction, this position is responsible for the OEM department fiscal administration. During disaster response, this position will manage the City's financial recovery efforts in coordination with the State and FEMA.
- Special Projects Manager (0866) Under general direction, is responsible for working within the Emergency, Financial & Governmental communities including technical experts, agency managers, and public safety department chiefs, City Officials, State and Federal Agencies in the management of the City's emergency management program. Implements the comprehensive all-hazard Emergency Management program, including Weapons of Mass Destruction (WMD)/Terrorist related activities within San Antonio.
