

AN ORDINANCE 2018-06-21-0495

APPOINTING CLARISSA L. CHAVARRIA, LISA M. GONZALES, DANIEL GUERRERO, LINDA HAYNES-HARRISON, JAMES DANIEL KASSAHN, CHRISTINE DAUPHINE LACY, CARLA MARIE OBLEDO, MICHAEL RAMOS, MARGARITA S. POL, AND PETER ANDREW ZAMORA AS FULL-TIME MUNICIPAL COURT JUDGES AND APPOINTING MELANIE A. CASTILLO, LAUREN M. LEFTON, JAVIER ROCHA, CARMEN R. ROJO, FRANK D. SANDOVAL, ALFREDO MACIAS TAVERA, AND AIDA ANN ZARAGOZA AS PART-TIME MUNICIPAL COURT JUDGES FOR THE REMAINDER OF A TWO-YEAR TERM EXPIRING APRIL 30, 2020.

WHEREAS, there are currently nine full-time and four part-time Municipal Court Judges, appointed by the City Council; and

WHEREAS, the number of full- and part-time Municipal Court Judges has been expanded to ten full-time and nine part-time, to address additional staffing needed for court and Magistrate duties; and

WHEREAS, the Municipal Court Advisory Committee met on June 12, 2018 to interview the current full-time Municipal Court Judges and selected applicants for full- and part-time Municipal Court Judges and, after finding that each applicant met the qualifications to serve, voted to bring their recommendations forward for full Council consideration; and

WHEREAS, after review and consideration of the qualifications and performance of the applicants for full- and part-time time Municipal Court Judges, the City Council finds that it is in the best interests of the City to appoint the Municipal Court Advisory Committee nominees as Judges; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following persons are appointed to serve as full-time Municipal Court Judges for the City of San Antonio Municipal Court for the remainder of terms expiring April 30, 2020:



SECTION 3. Annual salaries for the full-time Judges are established at \$105,392.56. Compensation for part-time Judges is \$45.48 per hour worked. Life insurance and health and retirement benefits currently extended to City employees are extended to the full-time Judges.

SECTION 4. This ordinance is effective immediately upon the receipt of eight affirmative votes, or, in the event eight affirmative votes are not received, ten days after passage.
