APPOINTING AND REAPPOINTING MEMBERS TO THE BUILDING-RELATED AND FIRE CODES APPEALS AND ADVISORY BOARD FOR THE REMAINDER OF UNEXPIRED TERMS OF OFFICE TO EXPIRE MAY 31, 2015, AND WAIVING THE CITY CODE RESIDENCY REQUIREMENT IN CHAPTER 2, ARTICLE IX, SEC. 2-529(B) FOR SPECIFIED APPOINTEES.

SECTION 2. The residency requirement in Section 2-529 (b) of the City Code is waived for specified [*] appointments.




