## AN ORDINANCE

AUTHORIZING AN EXTENSION AND FIFTH AMENDMENT TO THE TICKETING SERVICES AGREEMENT WITH TICKETMASTER, L.L.C. TO PROVIDE EXCLUSIVE EVENT TICKETING SERVICES FOR THE CONVENTION & SPORTS FACILITIES DEPARTMENT, EXERCISING THE AVAILABLE FIVE-YEAR RENEWAL OPTION FROM JULY 1, 2014, THROUGH JUNE 30, 2019.

WHEREAS, pursuant to Ordinance No. 2009-06-25-0590, City Council authorized a Ticketing Service Agreement (the "Agreement") with Ticketmaster, L.L.C. ("Ticketmaster") for events at the Henry B. Gonzales Convention Center, the Alamodome, and the Carver Community Cultural Center, with an initial term of five years, and a five-year renewal option; and

WHEREAS, this proposed Extension Agreement and Fifth Amendment to the Ticketing Services Agreement ("Fifth Amendment") with Ticketmaster exercises the available five-year renewal option from July 1, 2014, through June 30, 2019, adjusts customer fees, increases the City revenue share, adds a customized mobile application for events held at the Alamodome, and incorporates various administrative amendments to terms and conditions, which will result in estimated City revenue of \$4,950,037.00 during the extension period; NOW THEREFORE:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The terms and conditions of the Extension and Fifth Amendment to the Ticketing Services Agreement are authorized and approved. The City Manager, or her designee, is authorized to execute the Extension and Fifth Amendment, a copy of which has been executed by Ticketmaster and is attached to this Ordinance as **Exhibit I.** 

**SECTION 2.** Funds generated by this Ordinance for the first year of this Extension and Fifth Amendment will be deposited as per the table below:
