# Background

- 200 independent taxicab drivers submitted a petition requesting creation of an owner/operator permit category for drivers
- Transportation Committee suggested a neutral party to mediate between taxi companies, taxi co-ops, and taxi drivers.
- Mediation occurred on February 23, 2018
- 8 Participants from taxi companies, co-ops, and independent drivers

# Background



- Mediator presented her conclusions to the Transportation Council Committee on March 27, 2018.
- Mediator & staff also presented to the Transportation Advisory Board (TAB) on April 23, 2018.
- After a lengthy discussion, the TAB approved a recommendation to create independent operator permits

# Recommendation



- Create independent operator taxi permits
- Issue 75 permits to new single taxicab companies in 3 different distributions.
  - Redirect 32 existing permits to be released by October 1, 2018
    - 25 from Yellow Cab
    - 7 from population formula
  - 25 New Permits shall be released on October 1, 2019
  - 18 New permits shall be released on October 1, 2020.
- The Chief of Police has the authority to release permits ahead of schedule if demand requires after October 1, 2019.
