Re: S.P. 1908 Request for Joint Use Agreement to place bus shelters on thirteen (13) city owned/controlled properties

Dear Ms. Rodriguez,

With reference to the captioned project, please be advised that the City of San Antonio has now completed the canvassing process and will recommend approval of your request subject to the following conditions:

Transportation & Capital Improvements - Traffic Engineering:

99917 New Braunfels @ East Commerce (Cemetery #4) – Move 90’ – 100’ north due to sight distance issue. Contact: Christina De La Cruz, 207-7732; christina.delacruz@sanantonio.gov.

Office of Historic Preservation: In accordance with the applicable procedures of Chapter 35 of the City Code, the Joint User shall be required to obtain the appropriate Certificates of Appropriateness from the HDRC/HPO (“approvals”). If the 13 bus shelters to be installed under this agreement are to be of the previously approved “Next Gen” design, the Joint User shall be required only to obtain approval of the specific locations designated herein. However, if the Joint User proposes to install bus shelters of a design other than the “Next Gen” design, such design shall require approval of the HDRC separately from the required approval of the proposed installation locations.

Fire:

49539 - Culebra violates the 45 degree rule. The area within the 45 degree line area shall have no structures or vegetation that would obstruct the view of our exiting units. *“Shelters may not encroach in an area defined by a line from the corner of the door of the Fire Station at a 45 degree angle to the street.”* Contact: Carl Wedige, 207-8496; carl.wedige@sanantonio.gov.


