CONTAINED AMENDING THE LAND USE **PLAN** IN THE WEST/SOUTHWEST **SECTOR** PLAN, \mathbf{A} **COMPONENT OF** THE COMPREHENSIVE MASTER PLAN OF THE CITY, BY CHANGING THE USE OF LOT 1 NCB 18050, SAVE AND EXCEPT A 0.078 ACRE PARCEL CONVEYED TO THE STATE OF TEXAS LOCATED AT 7416 GRISSOM ROAD, FROM SUBURBAN TIER TO SPECIALIZED CENTER.

WHEREAS, the West/Southwest Sector Plan was adopted on April 21, 2011 by City Council as a component of the City's Comprehensive Master Plan adopted May 29, 1997; and

WHEREAS, the Unified Development Code requires consistency between zoning and the Comprehensive Master Plan and Section 213.003 of the TEXAS LOCAL GOVERNMENT CODE allows amendment of the Comprehensive Master Plan following a public hearing and review by the Planning Commission; and

WHEREAS, a public hearing was held on October 28, 2015 by the Planning Commission allowing all interested citizens to be heard; and

WHEREAS, the San Antonio City Council has considered the effect of this amendment to the Comprehensive Master Plan of the City and has determined that it conforms to the approval criteria set forth in the Unified Development Code §35-420, Comprehensive, Neighborhood, Community, and Perimeter Plans; NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The West/Southwest Sector Plan, a component of the Comprehensive Master Plan of the City, is hereby amended by changing the use of Lot 1 NCB 18050, save and except a 0.078 acre parcel conveyed to the State of Texas in the Deed at Volume 3718 Page 1723 of the Official Public Records of Bexar County, Texas located at 7416 Grissom Road, from Suburban Tier to Specialized Center. All portions of land mentioned are depicted in **Attachments "I"** and **"II"**, attached hereto and incorporated herein for all purposes.

SECTION 2. This ordinance shall take effect December 27, 2015.


