WHEREAS, the adopted FY 2015 budget provides for individual City Council district discretionary funds, commonly referred to as City Council Project Funds (CCPF) for programs, activities, events, scholarships, goods, or services that promote specified municipal public purposes set out in guidelines approved by City Council pursuant to Ordinance 2011-12-08-1011 dated December 8, 2011 and updated pursuant to Ordinance 2013-11-7-0761; and

WHEREAS, The Mayor's Commission on the Status of Women was established to review matters affecting the employment opportunities, education, social, civic, and political participation of women and various City Council members desire to provide CCPF support for the Commission's Pathways to Leadership Scholarship Fund in an amount of \$34,500.00 for Bexar County high school female graduates that plan to pursue a degree or certification at any two or four year accredited college, university, vocational or technical school; and

WHEREAS, the Annual Raul Jimenez Thanksgiving Dinner provides a hot and nutritious turkey dinner with all the trimmings to residents and various City Council members desire to provide CCPF support in an amount not to exceed \$14,318.00 to reimburse the organizers for costs incurred at the dinner held at the Henry B. Gonzalez Convention Center on November 27, 2014; and

WHEREAS, City Council District 7 held a Christmas Tree Lighting Celebration and hosted their Annual Award Excellence Leadership Banquet on December 9, 2014 and the Councilman desires to use CCPF to reimburse eligible costs related to the event in the amount of \$13,061.26; and

WHEREAS, City Council members for Districts 2 and 10 desire to provide CCPF to the Department of Transportation and Capital Improvements in the amounts of: (i) \$19,957.79 for the purchase and installation of area lighting adjacent to the recently upgraded Pittman-Sullivan Basketball Courts in District 2; and (ii) \$21,000.00 for the District 10 Safety Program that seeks to improve school zone safety at schools located in City Council District 10; NOW THEREFORE:
