

AN ORDINANCE 2020-02-20-0105

APPROVING THE ACCEPTANCE OF FUNDS NOT TO EXCEED \$9,300.00, FROM THE CONSERVATION SOCIETY OF SAN ANTONIO FOR CONSULTATION SERVICES FOR THE SCOUTSA SURVEY.

* * * * *

WHEREAS, the City of San Antonio (“City”) seeks to identify and inventory significant historic resources through the ScoutSA survey initiative; and

WHEREAS, this proactive effort responds to the community need for up-to-date information on properties that are potentially eligible for designation as local landmarks or historic districts; and

WHEREAS, in Fiscal Year 2018, the City’s Office of Historic Preservation (“OHP”) designed, tested, and implemented a new mobile application for collection of digital survey data and developed a prototype interactive map to share the information with the public more efficiently; and

WHEREAS, prior digitization projects have produced records for over 10,000 properties citywide, but some of these records are over 15 years old; and

WHEREAS, efforts to update and expand the survey through staff and volunteer projects are ongoing; and

WHEREAS, additional professional support for OHP staff would allow for greater coverage geographically and would help speed up the process for making survey data publicly available; and

WHEREAS, the City has preliminarily been awarded a cost reimbursement grant of \$9,300.00; and

WHEREAS, the estimated completion date for the project is December 2020; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The submission of a grant application to the Conservation Society of San Antonio and the acceptance of funds upon award, not to exceed \$9300.00 is hereby ratified. A copy of said grant application which is incorporated herein for all purposes is on file with the Office of Historic Preservation.



SECTION 3. Funds in an amount up to \$9,300.00 shall be appropriated in Fund 29829000, per the table below:




