

AN ORDINANCE 2014 - 09 - 11 - 0686

AWARDING A CITY COUNCIL PROJECT FUND GRANT ALLOCATION IN AN AMOUNT NOT TO EXCEED \$32,443.42 TO SAN ANTONIO SPORTS FOR THE FIT FAMILY CHALLENGE DISTRICT 4 HEROES 5K AND THE DISTRICT 6 FITNESS 5K AND \$13,137.18 TO THE SAN ANTONIO PUBLIC LIBRARY FOUNDATION TO SUPPORT SPECIAL PROGRAMMING

WHEREAS, the adopted FY 2014 budget provides for individual City Council district discretionary funds, commonly referred to as City Council Project Funds (CCPF) for programs, activities, events, scholarships, goods, or services that promote specified municipal public purposes set out in guidelines approved by City Council pursuant to Ordinance 2011-12-08-1011 dated December 8, 2011 and updated pursuant to Ordinance 2013-11-07-0761; and

WHEREAS, the San Antonio Sports (SAS) Fit Family Challenge began in 2010 and is a free annual 4-month county wide family fitness program conducted by SAS between May and August with the goal of improving the health and wellness of San Antonio families through routine family-friendly physical activity and nutrition education; and

WHEREAS, the City Councilmen for Districts 4 and 6 seek the approval of CCPF awards to SAS of amounts not to exceed \$17,662.55 and \$14,780.87 for San Antonio Sports Fit Family Challenge events previously held in these City Council districts; and

WHEREAS, certain Council members are also seeking the approval of a CCPF award to the San Antonio Public Library Foundation in the amount of \$13,137.18 to support the Foundation's special programming for youth, teens and families such as hands-on activities, author readings, lectures, panel discussions, and film screenings; and

WHEREAS, this initiative meets the objectives set out in the CCPF Guidelines and it is the desire of City Council to support these requests; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The requests by: (1) City Council District 4 for approval of a CCPF award to San Antonio Sports in an amount not to exceed \$17,662.55 for the Fit Family Challenge District 4 Heroes 5K Run held May 17, 2014; and (2) City Council District 6 for approval of a CCPF award to San Antonio Sports in an amount not to exceed \$14,780.87 for the District 6 Fitness 5K Run held June 7, 2014, are hereby approved.

SECTION 2. The request by certain Council members seeking the approval of a CCPF award to the San Antonio Public Library Foundation in the amount of \$13,137.18 to support the Foundation's special programming as specified above is hereby approved.

SECTION 3. Funding for this Ordinance is available as part of the Fiscal Year 2014 budget according to the following table:

SECTION 4. Payment not to exceed the budgeted amount of \$32,443.42 is authorized to San Antonio Sports and should be encumbered with a purchase order.

SECTION 5. Payment not to exceed the budgeted amount of \$13,137.18 is authorized to the San Antonio Public Library Foundation and should be encumbered with a purchase order.

SECTION 6. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


SECTION 7. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


