This Certificate of Exemption is executed and filed with the Finance Department as follows:

1. The undersigned is authorized to approve an exemption.
2. An exemption according to Section 252.022 of the Local Government Code exists. More specifically, the following event has occurred:

A temporary contract with Selrico was necessary due to a suspension of the custodial contract with the previous contractor. This contract is necessary to ensure the facility is kept clean for public events held at the Alamodome. CSF is currently working with Purchasing to solicit custodial contract services which is anticipated for Council approval in May 2017. An amendment for an extension of the temporary contract with Selrico is necessary to ensure that the Alamodome is not without a cleaning contractor.

3. Because the exemption stated above exists, the City of San Antonio intends to contract with Selrico which will cost approximately \$ \$466,168.00.
