The applicant is requesting Historic Tax Verification for the property at 293 W Hermosa.

*UDC Section 35-618 Tax Exemption Qualifications:* 

(e) Verification of Completion. Upon completion of the restoration and rehabilitation, together with a fee as specified in Appendix "C" of this chapter, the owner, who may not be the same as at the time of application, shall submit a sworn statement of completion acknowledging that the historically significant site in need of tax relief to encourage preservation has been substantially rehabilitated or restored as certified by the historic and design review commission. The historic and design review commission, upon receipt of the sworn statement of completion, but no later than thirty (30) days thereafter, shall make an investigation of the property and shall recommend either approval or disapproval of the fact that the property has been substantially completed as required for certification. If the historic and design review commission recommends that it has not been substantially completed as so required, then the certified applicant may be required by the historic preservation officer to complete the restoration or rehabilitation in order to secure the tax exemption provided herein. If the verification of completion is favorable, the historic and design review commission shall recommend approval and the historic preservation office may notify the tax assessor-collector in writing of compliance. Thereafter, the tax assessor-collector shall provide the property with the historic tax exemption.

## **FINDINGS:**


- a. The primary structure located at 293 W Hermosa is a 1-story single family home designed with Spanish Eclectic influences. The home was constructed in 1939 and features a stone façade, red composition shingle roof, and a front porch with a low-sloped hipped roof and square stone columns. The home is a contributing structure in the Olmos Park Terrace Historic District, which was designated in 2007. The applicant is requesting Historic Tax Verification.
- b. This property received Historic Tax Certification on February 15, 2017. The scope of work consisted of various items that were administratively approved or were confined to the interior, including wood window restoration, stone cleaning and repair, exterior painting, electrical, plumbing, new HVAC, kitchen and bathroom updates, and drywall. The scope of work also included a rear addition.
- c. Staff conducted a site visit on August 8, 2017. Staff commends the applicant for the quality and care of the rehabilitation efforts undertaken on this property. The outcome of the work is exemplary and an outstanding example of reinvestment.
- d. The applicant has met all requirements of the City's tax verification process as described in Section 35-618 of the UDC and has furnished evidence to that effect to the Historic Preservation Officer.
- e. The approval of Tax Verification by the HDRC in 2017 means that the property owners will be eligible for the Substantial Rehabilitation Tax Incentive beginning in 2018.

#### **RECOMMENDATION:**

Staff recommends approval as submitted based on findings a through e.
