

AN ORDINANCE 2012-09-20-0731

AUTHORIZING THE ACQUISITION THROUGH NEGOTIATION OF APPROXIMATELY 850 ACRES OF LAND LOCATED IN COUNCIL DISTRICTS 2, 3, 6, 8 AND 9, ALONG SAN ANTONIO CREEKWAYS FOR THE LINEAR CREEKWAY DEVELOPMENT PROJECT, A 2010 PROPOSITION 2 SALES TAX INITIATIVE FUNDED PROJECT.

WHEREAS, these properties consist of approximately 850 acres of land located along San Antonio creekways within Council Districts 2, 3, 6, 8 and 9 and are within the San Antonio city limits or extraterritorial jurisdiction, of Bexar County, Texas; and

WHEREAS, the acquisition of these properties is pursuant to implementation of the Linear Creekway Parks Development Project approved by voters in November of 2010; and

WHEREAS, the estimated total fair market value of the land for these acquisitions is \$3,400,000.00 and the properties are primarily located within the 100 year floodplain;
NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Director of the Department of Parks and Recreation or his designee, is authorized to negotiate and execute contracts for the acquisition of approximately 850 acres of land located in Council Districts 2, 3, 6, 8 and 9, along San Antonio creekways for the Linear Creekway Development Project, a 2010 Proposition 2 Sales Tax Initiative funded project. Maps of the approximate areas of land to be acquired are attached hereto as **Exhibit I**.

SECTION 2. The City Manager or her designee, or the Director of the Department of Parks and Recreation or his designee is further authorized to execute any and all necessary documents to effectuate said acquisitions.

SECTION 3. Payment in the amount of the estimated fair market value over the next 5 years, of various parcels of land valued at approximately \$3,400,000.00 in SAP Fund 40005000, Park Improvements, is authorized to be encumbered and made payable for the the acquisition of approximately 850 acres of land along Citywide Creekway, Leon Greenway to Salado Greenway Connect, Espada Connection, Culebra Creek (Leon Greenway At Cathedral), and the Salado Creek (Southside Lions Park to Se Military Drive) located at NCB 10835, 10839, NCB 10848, NCB 10865, NCB 10933, NCB 12174, NCB 14747, NCB 14853, NCB 14854, NCB 14859, NCB 15010, NCB 15011, NCB 15647, NCB 16334, NCB 17638, NCB 17639, NCB 17701, NCB 17857, NCB 17929, NCB 34763, NCB 34763, 34777 and CB 4002, in Council Districts 2, 3, 6, 8 and 9, along San Antonio Creekways in Bexar County, Texas from previously appropriated funds.

Payments for services are contingent upon the availability of City of San Antonio, 2010 Sales Tax Venue funds in accordance with the adopted capital budget. Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved operating and/or capital budgets for current and future fiscal years.

SECTION 4. The acquisition of property for the City of San Antonio must be coordinated through the city's Finance Department to assure the addition of these asset(s) to the City's financial records and the proper accounting of these transactions.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.










Proposed Land Acquisition Parcels for
