Description of Event/Purpose (Attach Document: 200-300 words):

Tickets to Literacy is an outreach program which has been offered annually by The Magik Theatre since 2005. This program focuses on enabling Title 1 schools and social service organizations that work with children from economically disadvantaged families to have the opportunity to attend Magik productions and/or host our touring productions at discounted rates or for free. Each of the schools and organizations involved are required to apply for this funding and are requested to augment the experience by using our classroom guides or requesting a teaching artist for pre or post show workshops in order to increase the educational experience. Magik performances are linked to age appropriate literature that is popular in schools to ensure that attending the performances is even more powerful.

The funds are allotted on a first come/ first served basis after qualification. Since 2010 over 100,000 students who otherwise may not have been able to attend a performance at Magik were able to do so as a direct result of Tickets to Literacy funding. When the number of requests received outnumbers the amount of Tickets to Literacy available, a preference is given to schools that have not recently attended. Regular school ticket prices are \$6 per student. All applicants are asked to pay \$2 per student to maximize the number of children that can attend a performance as a result of this funding. Schools who are unable to pay are not excluded from this opportunity. Funds are allocated by individual City Council Districts and utilized for schoolchildren within that district area. Magik respectfully requests that each Council District, consider giving a minimum of \$1,500 and optimistically allot the entire request of \$3,000 per district which would allow a possibility of up to 750 children from your district to attend.

Please include a detailed description of what the funds will be used for (List specific items being funded):

Funding allotted for this program is utilized to assist in offsetting the operating expenses at The Magik Theatre and specifically for our performances. The actual operating cost for the theatre is just under \$10/ticket. During our public performances we charge \$13.50 per ticket in order to be able to discount our student tickets to \$6/ticket. However, within San Antonio, we often find that even \$6/ticket is too much for many schools and social service programs. Tickets to Literacy enables us to subsidize their financial capacity and provide this vital literature based quality performance opportunities for their student


