

ORDINANCE 2019-05-30-0438

AUTHORIZING A FIRST AMENDMENT TO THE AUDIO VISUAL TECHNICAL ASSISTANCE AGREEMENT WITH PMI STAFFING SERVICES, LLC TO INCREASE THE CONTRACT AMOUNT BY \$100,000.00 ANNUALLY, FOR A TOTAL ANNUAL AMOUNT NOT TO EXCEED \$250,000.00.

WHEREAS, Ordinance No. 2017-12-14-1012, approved on December 14, 2017, authorized a Professional Services Agreement (“Agreement”) with PMI Staffing Services, LLC (“PMI”) to provide skilled staffing for the audio visual needs of the Alamodome, on an as-needed basis, for a three-year period with one additional two-year extension, for an estimated amount of \$150,000.00 annually; and

WHEREAS, PMI provides qualified technical staffing who augment the Alamodome full-time staff responsible for managing the audio visual needs of the Alamodome for events such as Monster Jam, Disney on Ice, and sporting events such as University of San Antonio football games; and

WHEREAS, funding for the Agreement is provided by the applicable Alamodome clients as a service chargeback; and


WHEREAS, since the inception of the Agreement, the number of events days at the Alamodome has increased, making it necessary to increase the Agreement capacity to handle the highly technical demand of hosting events; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and conditions of the First Amendment to the Professional Services Agreement with PMI Staffing Services, LLC, to provide supplemental audio visual services at the Alamodome, are authorized and approved. The City Manager, or his designee, is authorized to execute the First Amendment. A copy of the First Amendment, previously executed by PMI Staffing Services, LLC, is attached to this Ordinance as **Exhibit I**.


SECTION 2. This Ordinance shall take effect immediately upon the receipt of eight affirmative votes; otherwise it shall be effective ten days after its passage.

**FIRST AMENDMENT TO
PROFESSIONAL SERVICES AGREEMENT FOR
AUDIO VISUAL TECHNICAL ASSISTANCE**

This First Amendment to the Professional Services Agreement for Audio Visual Technical Assistance with PMI Staffing Services, LLC ("First Amendment") is entered into by the City of San Antonio, a Texas Municipal corporation ("City"), acting by and through its City Manager and PMI Staffing Services, LLC ("Contractor"), acting by and through its Owner, as authorized and approved by Ordinance No. 2019-05-30-_____.

RECITALS

- A. City and Contractor entered into the Professional Services Agreement for Audio Visual Technical Assistance ("Agreement") effective October 1, 2017.
- B. **City and Contractor agree to amend specific provisions of the Agreement as set out in this First Amendment.**
 - 1. **Section 4.1 is amended to increase the total annual payment to an amount not to exceed \$250,000.**

Except as otherwise expressly modified, all terms and provisions of the Agreement are ratified and confirmed and shall remain in full force and effect, enforceable in accordance with their terms.
