1. Discussion and possible action on an SEP-HCP application for the Bulverde Road Phase IV project (SEP 20-001), in unincorporated Bexar County, generally located along the right-of-way of Bulverde Road from TPC Parkway north to just north of Elm Waterhole Creek, in northwest Bexar County.

Tony Felts, Policy Administrator, presented item. The project consists of approximately 16.47 acres of existing right-of way along Bulverde Road from TPC Parkway to Marshall Road. The applicant provided a copy of the US Fish and Wildlife Section 7 Consultation, which determined that that the proposed action was not likely to adversely affect the Golden-cheeked Warble. Also, this project does not have any black-capped vireo (BCV) habitat and will not require any BCV conservation credits. The project area is located over Karst Zone 1 and Karst Zone 2 a total of 16.48 acres. The project is not located within any Critical Habitat Units nor is it within 750-ft of any occupied features.

2. Discussion and possible action on an SEP-HCP application for the Alamo Ranch Parkway project (SEP 20-002), in San Antonio City Council District 6 and unincorporated Bexar County, generally located along the right-of-way of Alamo Ranch Parkway from Loop 1604 west to 0.3 miles west of Westwood Loop, in western Bexar County.

Tony Felts, Policy Administrator, presented item. The project consists of approximately 15.1 acres of existing right-of way along Alamo Ranch Parkway extending approximately 0.5 miles from FM 1604 westward 0.3 miles past Westwood Loop. The applicant provided a copy of the US Fish and Wildlife Section 7 Consultation, which determined that that the proposed action was not likely to adversely affect the Golden-cheeked Warble. Also, this project does not have any black-capped vireo (BCV) habitat and will not require any BCV conservation credits. The project area is located over Karst Zone 2 a total of 15.1 acres. The project is not located within any Critical Habitat Units nor is it within 750-ft of any occupied features.

Tony Felts, Policy Administrator, presented item. This project will require no GCW or BCV conservation credits. This project is over Karst Zone 1, Karst Zone 2 and Karst Zone 3 and totals 25.87 acres. The project is not located within any Critical Habitat Units nor is it within 750-ft of any occupied features.
