

AN ORDINANCE 2016-06-09-0430

ACCEPTING THE BID FROM SUPERIOR TRAILER SALES TO PROVIDE EIGHT REPLACEMENT 26 CUBIC YARD END DUMP TRAILERS WITH ELECTRIC ROLL TARP COVER SYSTEMS TO THE CITY'S TRANSPORTATION AND CAPITAL IMPROVEMENTS DEPARTMENT FOR A TOTAL COST OF \$291,320.00, FUNDED FROM THE EQUIPMENT RENEWAL AND REPLACEMENT FUND.

WHEREAS, a bid was submitted to provide the City of San Antonio with end dump trailers with electric roll tarp cover systems which will be used to transport aggregates, asphalt mix and other paving materials throughout the City; and

WHEREAS, the lowest bid was submitted by Superior Trailer Sales for a total cost of \$291,320.00; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bid submitted by Superior Trailer Sales to provide the City with end dump trailers for a total cost of \$291,320.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. Attached hereto and incorporated herein for all purposes as Exhibit I are the bid tabulation sheet and bid.


SECTION 2. Funding in the amount of \$291,320.00 for this ordinance is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5501055, as part of the Fiscal Year 2016 Budget.

SECTION 3. Payment not to exceed the budgeted amount is authorized to Superior Trailer Sales and should be encumbered with a purchase order.


SECTION 4. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 5. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.


