

**A RESOLUTION 2013-12-19-0044R**

**ACKNOWLEDGING THE RESIGNATION OF COUNCIL MEMBER CARLTON SOULES, DISTRICT 10; AND INITIATING PROCEDURES TO SELECT A REPLACEMENT COUNCIL MEMBER.**

**WHEREAS**, on Monday, December 9, 2013, Council Member Carlton Soules, District 10 representative on the City Council, resigned from his place on the Council; and

**WHEREAS**, pursuant to the City of San Antonio City Charter, Section 8, a vacancy on the Council may be filled by a majority vote of the remaining members until an election may be held to fill the office for the remainder of the unexpired term; and

**WHEREAS**, Ordinance No. 2010-05-06-0375 establishes procedures for the appointment of temporary replacement Council Members in the event of a vacancy; **NOW THEREFORE**:

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Council acknowledges the resignation of Council Member Carlton Soules, District 10.

**SECTION 2.** The City Council directs the City Clerk to immediately post notice on the City website and publish, as soon as possible, advertisements in the local newspaper, inviting qualified residents of the district to submit applications, letters of interest, resumes, and disclosure statements to the City Clerk.

**SECTION 3.** The City Clerk is authorized to begin accepting applications, letters of interest, resumes and disclosure statements on Thursday, January 2, 2014.

**SECTION 4.** The deadline to submit applications, letters of interest, resumes, and disclosure statements to the City Clerk is 5:00 p.m., Wednesday, January 15, 2014.

**SECTION 5.** The City Council will interview qualified applicants of interest at the Council's "B" Session on Wednesday, January 29, 2014, and select up to three applicants to be interviewed at the Council's "A" Session on Thursday, January 30, 2014.

**SECTION 6.** The City Council will vote on the applicants for District 10 at the Council's "A" Session on Thursday, January 30, 2014. The successful applicant for appointment will be sworn in and take office at that meeting.

**SECTION 7.** In accordance with the City Charter requirements, a Special Election shall be called at a later date, to be held on the next uniform election date, May 10, 2014, to elect the replacement Council Member.


**SECTION 8.** This Resolution is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

  - The City Clerk publishes Notice of Vacancy in the Express-News and La Prensa on Sunday, December 22, 2013.

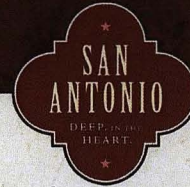

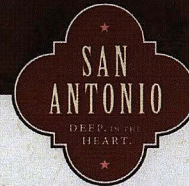
## Application Period



- Application Period is from Thursday, January 2 through 5 pm on Wednesday, January 15, 2014.
- Per Ordinance 2010-05-06-0375: Applicants shall complete an Application and submit a Letter of Interest, Resume, and Financial Disclosure Statements.
- The City Clerk will review Applications and forward same to the Mayor and City Council.

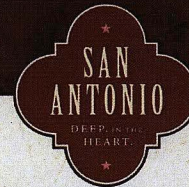
## Review and Appointment Process

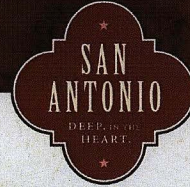
## Special Election
