

AN ORDINANCE 2013-11-07-0752

AUTHORIZING A TEMPORARY CLOSURE MULTI-YEAR AGREEMENT WITH THE TEXAS DEPARTMENT OF TRANSPORTATION ALLOWING THE TEMPORARY STREET CLOSURE OF SPECIFIED STATE RIGHTS OF WAY ALONG THE SAN ANTONIO ROCK 'N' ROLL MARATHON & 1/2 MARATHON ROUTE FOR A TERM OF ONE (1) YEAR WITH A MUTUAL OPTION TO EXTEND AND CHANGE THE SAN ANTONIO ROCK 'N' ROLL MARATHON & 1/2 MARATHON EVENT DATE EACH YEAR FOR FOUR (4) ADDITIONAL YEARS.

WHEREAS, on November 17, 2013 the City will be co-sponsoring the annual San Antonio Rock 'n' Roll Marathon & 1/2 Marathon; and

WHEREAS, this event attracts over 30,000 participants in addition to tens of thousands of volunteers and spectators, plus this year's event will once again include a bicycle tour of the route, which will begin prior to the start of the race and in order to ensure a safe environment for all participants the closure of various roadways is required; and

WHEREAS, several of the roadways to be used during this event are state-owned roadways and authorization for temporary closure is needed from the Texas Department of Transportation (TxDOT) and based on TxDOT policy, authorization for temporary closures of state-maintained roadways is formally granted by agreement, that must be executed between governmental jurisdictions which will be impacted by the temporary road closures; and

WHEREAS, the Public Works Department staff, in coordination with Downtown Operations and SAPD, has developed the Traffic Control Plan that will be utilized during the temporary street closures and SAPD will be responsible for directing traffic along the detour route; and

WHEREAS, this Ordinance will authorize the execution of the Temporary Closure Agreement between the TxDOT and the City of San Antonio for the temporary street closure along segments of Loop 13 (S.W. Military Dr.), Spur 122 (Presa), Spur 536 (Alamo/Roosevelt/Probandt), US 281, IH 37 and IH 35 on November 17, 2013 between the hours of 5:30 a.m. to 5:00 p.m.; and

WHEREAS, this City Council action will ensure that the temporary street closure will be permitted for this event; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. The City Manager or her designee is hereby authorized to execute a Temporary Closure Multi-Year Agreement with the Texas Department of Transportation for the temporary street closure along segments of Loop 13 (S.W. Military Dr.), Spur 122 (Presa), Spur 536

(Alamo/Roosevelt/Probandt), US 281, IH 37 and IH 35 between the hours of 5:30 a.m. to 5:00 p.m. on November 17, 2013.

SECTION 2. There is no financial impact with this Ordinance.

SECTION 3. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
