

ORDINANCE 2020-01-30-0041

APPOINTING CARLA OBLEDO AS MUNICIPAL COURT PRESIDING JUDGE FOR THE REMAINDER OF A TWO-YEAR TERM EXPIRING APRIL 30, 2021.

* * * * *

WHEREAS, John Bull, the Municipal Court Presiding Judge has tendered his resignation, triggering the need to appoint a new Presiding Judge for the remainder of the unexpired term, ending April 30, 2021; and

WHEREAS, the Municipal Court Advisory Committee met on January 8, 2020 to interview applicants, and after finding that Judge Carla Obledo met the state and local qualifications for the office, voted to bring its recommendation forward for full Council consideration; and

WHEREAS, after review and consideration of the qualifications and performance of Judge Carla Obledo for Municipal Court Presiding Judge, the City Council finds that it is in the best interests of the City to appoint her; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. In order to facilitate an orderly transfer of duties Carla Obledo is appointed Municipal Court Presiding Judge for the City of San Antonio Municipal Court effective January 30, 2020 for the remainder of a two-year term ending April 30, 2021. John Bull is titled Former Presiding Judge until his retirement date of February 29, 2020.

SECTION 2. Annual salary for the Municipal Court Presiding Judge is \$145,000.00, with added monthly car and cell phone allowances of \$500.00 and \$70.00, respectively. Life insurance and health and retirement benefits currently extended to City employees are extended to Presiding Judge.


SECTION 3. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon the receipt of eight affirmative votes, or, in the event eight affirmative votes are not received, ten days after passage.


