DESCRIPTION OF 0.012 ACRE TRACT

Being 0.012 Acres (527 Sq. Ft.) out of that 0.283 Acre tract of land described in a deed recorded in Volume 8235, Page 1020, Official Public Records, Bexar County, Texas, also being out of Lot 11, Block 24, N.C.B. 534 as shown on the City Engineers Map of the City of San Antonio, Bexar, County, Texas and being more particularly described as follows:

COMMENCING at a point at the intersection of the North Right-of-Way of Burnet Street and the East Right-of-Way of Live Oak Street, said point also being the Southwest corner of said 0.283 Acre Tract and the Southwest corner of said Lot 11 for the **POINT OF COMMENCEMENT**;

Thence, N00°17' 57"W, a distance of 104.96 feet with the east line of Live Oak Street to a ½" iron bar set for the southern most corner and the **POINT OF BEGINNING** of the herein described tract;

Thence, , N00° 17' 57"W, a distance of 35.95 feet continuing with the east line of Live Oak Street to a ½" iron set at the intersection of the East Right-of-Way line of Live Oak with the South Right-of-Way of Brooklyn Avenue, said point also being the northernmost corner of the herein described tract;

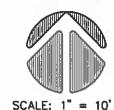
Thence, S52° 23' 04"E, a distance of 37.18 feet along the south Right-of-Way line of Brooklyn Avenue to a ½" iron bar set for the eastern most corner of the herein described tract;

Thence, S65° 37' 49"W, a distance of 32.12 feet, to the POINT OF BEGINNING containing 0.012 (4,117.78 square feet) acres of land, more or less.
