# <u>Division 7 – Thermal and Moisture... Eating Pavilion and Multi-use Pavilion Roof Repairs</u>

- Sweep off loose gravel approximately 14,950 s/f
- Install ½ in. fanfold insulation to entire roof area approximately 14,950 s/f
- Install new drip edge and flashings around perimeter of roofs approximately 720 l/f
- Mechanically fastened 60 mill TPO roofing system approximately 14,950 s/f
- Clean up and remove all roofing debris
- Seal penetrations
- Repair damaged metal panels as needed

## **Division 9 – Finishes... Cooking Pavilion Roof**

- Power Wash approximately 3,585 s/f
- Remove Rotted Trim as necessary
