

AN ORDINANCE 2017-12-14-0986

ACCEPTING THE BID FROM HOLT TEXAS, LTD. DBA HOLT CAT TO PROVIDE THE TRANSPORTATION AND CAPITAL IMPROVEMENTS DEPARTMENT WITH FOUR ASPHALT PLANER SKID STEER ATTACHMENTS FOR A TOTAL COST OF \$122,332.00, FUNDED FROM THE EQUIPMENT RENEWAL AND REPLACEMENT FUND.

WHEREAS, bids were submitted to provide the City of San Antonio with four asphalt planer skid steer attachments that will be utilized by the Transportation and Capital Improvements Department for street paving maintenance; and

WHEREAS, the lowest bid was submitted by Holt Texas, LTD. dba Holt Cat for a total cost of \$122,332.00; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The low bid from Holt Texas, LTD. dba Holt Cat to provide the City of San Antonio with asphalt planer skid steer attachments for a total cost of \$122,332.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheet and bid are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding for this ordinance in the amount up to \$122,332.00 is available in Fund 72001000, Cost Center 3503200001, General Ledger 5701080 as part of the Fiscal Year 2018 Budget.


SECTION 3. Payment not to exceed the budgeted amount is authorized to Holt Texas, LTD. dba Holt Cat and should be encumbered with a purchase order.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 5. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.


