

ORDINANCE 2020-12-03-0852

**APPROVING THE APPLICATION AND ACCEPTANCE OF A GRANT IN AN AMOUNT NOT TO EXCEED \$900,000.00 FROM THE TEXAS DEPARTMENT OF TRANSPORTATION FOR THE COMPREHENSIVE SELECTIVE TRAFFIC ENFORCEMENT PROGRAM FOR THE PERIOD FROM OCTOBER 1, 2021 THROUGH SEPTEMBER 30, 2022. THIS GRANT REQUIRES A \$265,000.00 CASH MATCH FROM THE GENERAL FUND.**

**WHEREAS**, the Texas Department of Transportation (TxDot) has a Comprehensive Selective Traffic Enforcement Program (STEP) Grant for the period of October 1, 2021 through September 30, 2022, in the amount of \$900,000.00; and

**WHEREAS**, the grant will be used to enhance traffic safety related to driving while intoxicated, speeding, occupant protection, distracted driving and intersection related violations; and

**WHEREAS**, this will be the twenty-second year TxDOT has offered this grant to SAPD; and

**WHEREAS**, this grant requires a General Fund cash-match of \$265,000.00 and in in-kind contribution of \$77,500.00, **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager and designee, and the San Antonio Chief of Police and designee, are hereby authorized to accept grant funds in an amount up to \$900,000.00 from the Texas Department of Transportation (TxDOT) for the Comprehensive Selective Traffic Enforcement Program (STEP) for the grant period of October 1, 2021 through September 30, 2022. This Ordinance also authorizes an in-kind match up to \$77,500.00, which will be fulfilled by the SAPD vehicles; and approves a required cash match of \$265,000.00 from the General Fund contingent upon available of funding in the fiscal year 2022 budget. A copy of said application is on file with the San Antonio Police Department.

**SECTION 2.** The City Manager and designee, and the San Antonio Chief of Police and designee, are hereby authorized to execute any and all necessary documents to effectuate said application and acceptance.


**SECTION 3.** Upon award, a new fund and internal order will be created for use in the accounting for the fiscal transaction in the acceptance of this grant and the amounts listed above totaling a sum not to exceed \$900,000.00 will be appropriated in said funds. A formal final budget which will include Internal Order numbers and General Ledger numbers will be submitted by the department upon award.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

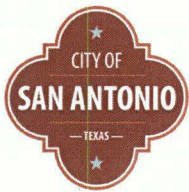
