

AN ORDINANCE 2015-04-02-0216

**AUTHORIZING THE EXECUTION OF A TASK ORDER TO A JOB ORDER CONTRACT WITH F.A. NUNNELLY CO. TO PROVIDE FOR HVAC PUMP SYSTEM REPLACEMENT AT THE MUNICIPAL PLAZA BUILDING LOCATED IN CITY COUNCIL DISTRICT 1, IN AN AMOUNT NOT TO EXCEED \$191,200.00, TO BE FUNDED THROUGH THE FY 2015 DEFERRED MAINTENANCE PROGRAM.**

**WHEREAS**, as part of the FY 2015 Budget, citywide facility needs including to the Municipal Plaza Building at 114 W. Commerce Street that are described below, will be addressed by the Deferred Maintenance Program; and

**WHEREAS**, Ordinance No. 2015-01-15-0013, passed and approved on January 15, 2015, authorized the issuance of a total of ten (10) Job Order Contracts (JOC) for an initial one (1) year term, with the option to renew each JOC for three (3) one (1) year extensions, with each JOC not to exceed \$2,000,000.00, in connection with construction, renovation, rehabilitation and maintenance projects in City facilities; and

**WHEREAS**, one JOC was authorized to be issued to F.A. Nunnelly Co.; and

**WHEREAS**, City Staff has determined that renovations to the Municipal Plaza Building located at 114 W Commerce Street in City Council District 1, are immediately necessary; and

**WHEREAS**, these renovations consist of replacement of the HVAC pump system used to cool the entire facility, and involve restructuring the piping arrangement from a series to a parallel configuration, replacing 4 water pumps with larger units, and installing new controls, electrical support and new control valves; and

**WHEREAS**, City Staff estimates that the cost of these renovations will not exceed \$191,200.00; and

**WHEREAS**, City Staff recommends that these renovations be performed by F.A. Nunnelly Co. pursuant to the JOC previously issued to it, and further recommends that City Council authorize the execution and issuance of a Task Order to F.A. Nunnelly Co. provide for such renovations and repairs; and

**WHEREAS**, following discussion of and deliberations on the City Staff recommendations set out above, the City Council has determined that it is appropriate and in the best interests of the City to accept them; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**


**SECTION 1.** The City Manager or her designee is authorized to execute a Task Order to a Job Order Contract with **F.A. NUNNELLY CO.** in an amount not to exceed \$191,200.00 for the construction of the HVAC pump system replacement at the Municipal Plaza Building.

**SECTION 2.** Payment in an amount not to exceed \$191,200.00 in SAP Fund 40099000, Other Capital Project, SAP Project Definition 35-00008, DM - Municipal Plaza Building, is authorized to be encumbered and made payable to F.A. Nunnelly Co., for pump system replacement.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.




