The City Council convened in a Special City Council Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

PRESENT: 10 - Mayor Taylor, Treviño, Warrick, Viagran, Saldaña, Lopez, Medina, Nirenberg, Krier and Gallagher

ABSENT: 1 - Gonzales

Mrs. Vacek announced that Councilmember Gonzales had given birth to a baby boy Zachary the previous day and would not be in attendance.

1. An Ordinance canvassing the June 13, 2015 run-off election results for Mayor and City Council District 7. [Leticia M. Vacek, City Clerk]

City Clerk Leticia Vacek presented the official results of the June 13, 2015 Run-Off Election for Mayor and City Council District 7. She presented the total Votes Cast for each candidate in the Run-Off Election as follows:

FOR MEMBER OF COUNCIL, MAYOR:

Ivy R. Taylor 50,662 votes (Includes 3 FPCA/Provisional Votes)
Leticia Van De Putte 47,331 votes (Includes 3 FPCA/Provisional Votes)

FOR MEMBER OF COUNCIL, PLACE NO. 7:

Mari Aguirre-Rodriguez 5,668 votes
Cris Medina 6,732 votes

Mrs. Vacek declared that as a result of the Run-Off Election, the following persons were elected for a two-year term of office commencing June 24, 2015:

Ivy R. Taylor, Member of Council, Mayor
Cris Medina, Member of Council, Place No. 7

Mrs. Vacek reported that the total number of votes cast, including 6 provisional ballots, was 98,350 and the total number of registered voters for the City of San Antonio was 696,469. She stated that the voter turnout for the City of San Antonio Run-Off Election was 14.12%.

Mrs. Vacek compared the General (Main) Election Results noting that 86,067 votes were cast in the May 9, 2015 Election while 692,349 voters were registered for said Election, and that the voter turnout was 12.43%.

Councilmember Gallagher moved to adopt the proposed ordinance canvassing the Election Results of the June 13, 2015 Run-Off Election. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

AYE: 10 - Mayor Taylor, Treviño, Warrick, Viagran, Saldaña, Lopez, Medina, Nirenberg, Krier and Gallagher

ABSENT: 1 - Gonzales
