

AN ORDINANCE 2015-06-18-0550

AMENDING THE OVERFLOW PARKING FEE AT SAN ANTONIO INTERNATIONAL AIRPORT AND THE CITY CODE OF SAN ANTONIO, TEXAS (CITY CODE) TO REFLECT SUCH CHANGES.

* * * * *

WHEREAS, the construction of the Consolidated Rental Car (CONRAC) facility at San Antonio International Airport will require the demolition of the hourly parking garage displacing parking and requiring parking in other areas to include overflow parking areas; and

WHEREAS, overflow parking areas have one rate of \$8.00 per day and staff from the Aviation Department would like to implement an incremental parking rate structures for this category of \$2.00 for up to one hour, \$4.00 from one to two hours, \$6.00 from two to three hours, and \$8.00 from three to twenty-four hours; and

WHEREAS, it is now necessary to amend Chapter 3, Section 3-179(3) of the City Code to implement the incremental rate structure outlined above for the overflow parking areas at San Antonio International Airport; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Overflow Parking Fee. Subsection 3-179(3) of the City Code of San Antonio is hereby amended by adding language that is underlined and ~~striking~~ deleted language to the existing language as set forth in this ordinance. All other language in this Section of the City Code remains unchanged.

Chapter 3, Subsection 3-179(3), is hereby amended as follows:

Sec. 3-179. (3) *Overflow Parking Fee:*

0-24 hours or fraction thereof:	— \$8.00
<u>0 - 1 hour or fraction thereof:</u>	<u>\$2.00</u>
<u>1 - 2 hours or fraction thereof:</u>	<u>\$4.00</u>
<u>2 - 3 hours or fraction thereof:</u>	<u>\$6.00</u>
<u>3 - 24 hours or fraction thereof:</u>	<u>\$8.00</u>

SECTION 2. Funds generated by this Ordinance will be deposited into Fund 51001000, Internal Order 233000000024 and General Ledger 4405300.

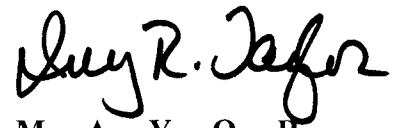

The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP

Cost Centers, SAP Functional Areas, SAP Funds Reservation Document numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
