

AN ORDINANCE 2016-01-14-0006

AWARDING A GRANT ALLOCATION THROUGH THE CITY COUNCIL PROJECT FUNDS PROGRAM TO MUSICAL BRIDGES AROUND THE WORLD IN AN AMOUNT NOT LESS THAN \$27,800.00 AND THE MAGIK THEATRE: TICKETS TO LITERACY PROGRAM IN AN AMOUNT NOT LESS THAN \$16,318.19; AND APPROVING ANY ADDITIONAL FUNDING WITHIN THIS FISCAL YEAR.

WHEREAS, the adopted FY 2016 budget provides for individual City Council district discretionary funds, commonly referred to as City Council Project Funds (CCPF) for programs, activities, events, scholarships, goods, or services that promote specified municipal public purposes set out in guidelines approved by City Council pursuant to Ordinance 2011-12-08-1011 dated December 8, 2011 and updated pursuant to Ordinance 2013-11-07-0761; and

WHEREAS, Musical Bridges Around the World strives to: (1) introduce children to other cultures through international folk music at its best; (2) promote peace and respect for cultural differences; and (3) assist teachers and schools in fulfilling Academic Standards; and

WHEREAS, because most public schools in San Antonio do not have the funds to provide live music experiences as outlined in the National Academic Standards, the agency's Kids to Concerts Program brings high quality interactive international folk music concerts to schools throughout the City, thereby helping school districts meet National Academic Standards in music, art and social studies; and

WHEREAS, City Council members from Districts 1, 2, 3, 4, 5, 6, 7, 8 and the Mayor desire to provide CCPF to Musical Bridges Around the World for the Kids to Concerts Program in a total amount of \$27,800.00; and

WHEREAS, The Magik Theatre initiated their Tickets to Literacy Program in 1996 to allow children in San Antonio to enjoy the educational, cultural, and artistic experience of attending theatrical performances for free; and

WHEREAS, this season the agency will produce seven full-scale shows based on classical and contemporary children's literature for its home stage and bring four shows to touring the schools; and

WHEREAS, City Council members from Districts 1, 2, 3, 4, 5, 6, 8, 10 and the Mayor desire to provide CCPF to The Magik Theatre's Tickets to Literacy Program in a total amount of \$16,318.19; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Funding to the Musical Bridges Around the World for the Kids to Concerts Program in an amount of \$27,800.00, and any additional funding within this fiscal year, is hereby approved. Funding for this allocation is made possible through CCPF contributions made by the following City Council Districts:


SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
