Medical Malpractice: (Homeland Insurance Company of New York)

- Expiring Premium: \$31,484
- **Renewal Premium: \$35,180**
- Coverage includes:
  - Errors and Omissions associated with the operation of medical and dental clinics
  - Individual doctors, dentists and affiliated medical personnel, and the City, are protected from liability
- Limit: \$1M per occurrence/\$3M general aggregate
- Deductible: \$25,000

Airport Owners and Operators Liability: (Commerce & Industry Insurance Company)

- Expiring Premium: \$43,950
- **Renewal Premium: \$62,373**
- Coverage includes:
  - Protection against third-party liability claims involving personal injury, property loss, and automobile accidents on Airport grounds
  - San Antonio International Airport and Stinson Field are covered
- Limit: \$10,000,000
- Deductible: \$0

Aircraft Hull Liability: (Commerce & Industry Insurance Company)

- Expiring Premium: \$118,744
- **Renewal Premium: \$152,427**
- Total Insured Value (TIV): \$11.4 M
  - Represents fleet of four SAPD helicopters and associated specialized equipment
- Coverage includes:
  - Protection against damage to assets
  - Liabilities associated with operation of helicopter fleet
- Limit: TIV:\$11,369,820
- Deductible: 2% of insured value of each aircraft

Crime Policy: (National Union Fire Insurance Company of Pittsburg, PA)

- Expiring Premium: \$12,856
- **Renewal Premium: \$18,248**
- Coverage includes:
  - Protection against employee dishonesty, theft, embezzlement, etc.
  - Covers currency, securities and other investment vehicles handled and processed by City employees
- Limit: \$1M
- Deductible: \$10,000

Fine Arts: (AXA Insurance Company)

- Expiring Premium: \$40,884
- **Renewal Premium: \$34,720**
- Total Insured Value (TIV): \$19.5M
  - Represents the City's most recent estimate of owned and/or leased art
- Coverage includes:
  - Paintings, Statues, Manuscripts
  - Historical Artifacts
- Limit: \$19.5M – Market Value
- Deductible: \$5,000

Property Insurance: (Factory Mutual Insurance Company)

- Expiring Premiums: \$1,307,332
- **Renewal Premium: \$1,532,519**
  - **Membership Credit of \$65,367 will be rebated to City upon renewal**
- Total Insured Value (TIV): \$3.12B
- Represents the City's estimated owned/leased buildings, contents, machinery and equipment
- Coverage includes:
  - Buildings & Contents
  - Boiler & Machinery used to heat and cool the buildings
  - Electronic and data processing equipment
- Limit: \$2 Billion - RC
- Deductible: \$100,000

Inland Marine: (XL Specialty Insurance Company)

- Expiring Premium: \$48,253
- **Renewal Premium: \$74,746**
- Total Insured Value (TIV): \$6.9M
- Represents the City's most recent values of 3 mobile command units
- Inland marine coverage includes:
  - Fire & Police Command Vehicles
  - Associated Special Equipment
- Limit: \$6.9M – ACV for mobile unit / RC for equipment
- Deductible: \$2,500 / \$100k flood / \$100k while in operation
