2. An exemption according to Section 252.022 of the Local Government Code exists. More specifically, the following event has occurred:

The San Antonio Metropolitan Health District (SAMHD) LRN Laboratory is part of a national laboratory response network (LRN) that provides testing to quickly respond to biological and other high priority public health emergencies. The Centers for Disease Control and Prevention (CDC) oversees this network and has established standardize requirements for all member laboratories such as specific equipment and protocots. To effectively serve the 29 counties in its jurisdiction, SAMHD LRN laboratory has acquired in previous grant cycles two Applied Biosystems (AB) 7500 Fast DX real-time PCR instruments, (SN:275930104 and SN: 278030188). To satisfy CDC performance measures specifically PHEP Capability 12, SAMHD Laboratory must maintain service agreements for all LRN required equipment. No other vention is certified to perform the preventative maintenance on AB7500 Fast DX instruments that will keep the equipment in good standing within CDC criteria.

Because the exemption stated above exists, the City of San Antonio Intends to contract with Life Technologies, Inc. which will cost approximately 19000.08
