WHEREAS, the low bid of \$1,600,490.00 was submitted by Freightliner of San Antonio, Ltd., who assigned most of its assets, including its franchise dealership and interest in this bid to Doggett Freightliner of South Texas, LLC.; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bid submitted by Doggett Freightliner of South Texas, LLC, assignee of Freightliner of San Antonio, Ltd., to provide the City with ten brush tractors with horizontal, rear discharge brush trailers for a total cost of \$1,600,490.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. Attached hereto and incorporated herein for all purposes as **Exhibit I** are the bid tabulation sheet and bid.

SECTION 2. Expenses not to exceed \$957,654.00 associated with this ordinance is available in Fund 55005002 through a purchase lease agreement. Principal and interest payments will be charged to Cost Center 5501290001 and General Ledgers 5709090.

SECTION 3. Funding in the amount of \$642,836.00 for this ordinance is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5501055, as part of the Fiscal Year 2014 Budget.

SECTION 4. Payment not to exceed the amount of \$1,600,490.00 is authorized to Doggett Freightliner of South Texas, LLC, assignee of Freightliner of San Antonio, LTD., and should be encumbered with a purchase order.
