### AN ORDINANCE 2014 - 03 - 20 - 0185

AUTHORIZING AN AMENDMENT TO THE INTERLOCAL AGREEMENT WITH THE BEXAR COUNTY HOSPITAL DISTRICT, D/B/A UNIVERSITY HEALTH SYSTEM (UHS) TO EXTEND THE TERM OF THE AGREEMENT AND AUTHORIZE THE ACCEPTANCE OF COMPENSATION FROM UHS IN THE AMOUNT OF \$95,384.04 FOR THE PERIOD APRIL 1, 2014 THROUGH SEPTEMBER 30, 2014.

WHEREAS, since 1965, Bexar County, and later the Bexar County Hospital District d/b/a University Health System (UHS), has contracted with the City of San Antonio for the San Antonio Metropolitan Health District (Metro Health) to provide certain public health services to residents of unincorporated Bexar County; and

WHEREAS, these services include dental screening and treatment, sexually transmitted disease control, tuberculosis control, emergency preparedness and response, and health education programs; and

WHEREAS, Metro Health also contracts with UHS for radiology services to support Metro Health clinical programs; and

WHEREAS, the responsibilities of both parties are defined in an Interlocal agreement that currently extends through March 31, 2014; and

WHEREAS, this Ordinance amends the current Interlocal agreement to extend the term and set out fees for the period April 1, 2014 through September 30, 2014; NOW THEREFORE:

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Director of the San Antonio Metropolitan Health District or his designee is authorized to execute an amendment to the Interlocal Agreement with the Bexar County Hospital District, d/b/a University Health System (UHS) to extend the term of the agreement and accept compensation from UHS in the amount of \$95,384.04 for the period April 1, 2014 through September 30, 2014. A copy of the agreement is attached hereto and incorporated herein for all purposes as Attachment I.

**SECTION 2.** Funds generated by this ordinance will be deposited into Fund 11001000, Internal Order 236000000011 and General Ledger 4301110.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP

Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

This Ninth Amendment to the Agreement for Services and Planning (the "Amendment") by and between the **City of San Antonio**, a home-rule municipality situated within Bexar County, Texas, herein called "CITY" and the **Bexar County Hospital District d/b/a University Health System**, a political subdivision of the State of Texas, herein called "UHS"), is entered into this 1<sup>st</sup> day of April, 2014, pursuant to the Texas Interlocal Cooperation Act.

### WITNESSETH

WHEREAS, the governing bodies of cities, counties and other governmental entities may establish health districts for the operation of a coordinated health program for the members of such districts; and

WHEREAS, the governing bodies of the CITY and Bexar County (COUNTY) have established a health district by mutual agreement; and

WHEREAS, effective January 1, 2009, UHS and the City entered into an Interlocal Agreement (the "Agreement") that is also referenced as City of San Antonio City Ordinance 2008-12-11-1171 to secure public health, laboratory, and emergency preparedness services for persons residing in unincorporated Bexar County from the CITY by and through the San Antonio Metropolitan Health District (HEALTH DISTRICT), and for the CITY to secure clinical and other services performed by UHS that complement and/or are required by the HEALTH DISTRICT; and

WHEREAS, UHS and City have previously amended the Agreement; to incorporate the agreed specific terms reflecting the amount of compensation to be paid by UHS for services provided by the CITY through the HEALTH DISTRICT for CITY fiscal and calendar years 2010 - 2013 and through March 31, 2014; and

WHEREAS, UHS and CITY have again reviewed the service needs of the community and the cost of service pursuant to Article VI of the Agreement and wish to extend the Agreement and amend the compensation accordingly to reflect the amount to be paid by UHS for services provided by the CITY through the HEALTH DISTRICT during the period of the extension between April 1, 2014 and September 30, 2014; and

NOW THEREFORE, the parties agree as follows:

## ARTICLE I PURPOSE AND EFFECTIVE DATE

1.01 The purpose of this Amendment is to amend the said Interlocal Services and Planning Agreement to incorporate the agreed specific terms regarding services to be provided by CITY through the HEALTH DISTRICT and compensation amount to be paid by UHS for said services as set out in Attachment A-9 for the period April 1, 2014 through September 30, 2014. This Amendment shall be effective April 1, 2014.

# ARTICLE II AMENDMENTS

- 2.01 Article II, "Term" is hereby amended as follows:
  - 2.01 By agreement of the PARTIES, the Interlocal Agreement between the PARTIES entered into on September 21, 2006 with a term beginning on October 1, 2006, and previously extended by written amendment, is hereby amended effective April 1, 2014 to end on September 30, 2014.
- 2.02 Article VI, "Cost of Service," is hereby amended to reflect the addition of 6.01.08, related to the payment for services by UHS:
  - 6.01.08 For the period beginning on April 1, 2014 through September 30, 2014, UHS agrees to pay, and the CITY agrees to accept, the total sum of NINETY FIVE THOUSAND, THREE HUNDRED EIGHTY FOUR AND 04/100THS DOLLARS (\$95,384.04) payable in equal monthly payments of FIFTEEN THOUSAND EIGHT HUNDRED NINETY SEVEN AND NO/100THS (\$15,897.34). The calculation of compensation for the period beginning on April 1, 2014 and ending on September 30, 2014 is shown on the revised Attachment A (now identified as Attachment A-9) which is attached hereto as a substitution for the previous Attachment A and incorporated herein as part of this agreement for all purposes.

# ARTICLE III TERMS AND CONDITIONS

3.01 All other terms and conditions of this Agreement remain in full force and effect.
