


This Certificate of Exemption is executed and filed with the Finance Department as follows:

1. The undersigned is authorized to approve an exemption.
2. An exemption according to Section 252.022 of the Local Government Code exists. More specifically, the following event has occurred:

The annual contract for Structural Firefighting Boots for the San Antonio Fire Department (SAFD) will expire on 9-30-19. In preparation for a new multi-year Boot contract, the SAFD Quartermaster office conducted a wear trial with the cooperation of the SAFD Personal Protective Equipment Committee. That trial concluded with a tie. Both the PRO Series NightHawk™ 5555 by Honeywell First Responder Products and the SUPREME™ 14" boot made by Globe Manufacturing were selected. Both boots excelled in durability, safety, function, and comfort.

3. Because the exemption stated above exists, the City of San Antonio intends to contract with TBD which will cost approximately \$ 880,000.
