AMENDMENT #1 TO DELEGATE AGENCY CONTRACT WITH CATHOLIC CHARITIES ARCHDIOCESE OF SAN ANTONIO, INC.

This amendment ("Amendment) to the Delegate Agency Contract ("Contract") for the Guadalupe Community Center Project ("Project") is entered into by and between the City of San Antonio, a Texas Municipal Corporation, (hereinafter referred to as "City") acting by and through its designated representative, the Director of the Department of Human Services, pursuant to Ordinance No. _______ passed and approved on _______, and the Catholic Charities Archdiocese of San Antonio, Inc. (hereinafter referred to as "Contractor").

WHEREAS, the City presently contracts with Contractor pursuant to a Delegate Agency Contract executed on ______ pursuant to Ordinance No.2014-09-18-0690; and

WHEREAS, the parties desire to amend the Contract to allocate an additional \$15,239.00 in funds to the Project; and

WHEREAS, it is in the best interest of the City that an amendment of the Contract now be executed which revises the Contractor's budget changing the total dollar amount of the Contract; NOWTHEREFORE:

City and District agree to amend the Agreement as follows:

1. The third WHEREAS clause in the Contract shall read as follows:

WHEREAS, the City has adopted a budget for the expenditure of such funds, and included therein is an allocation of \$33,989.00 for a project entitled the "Guadalupe Community Center" (hereinafter referred to as the Project"); and

2. Section 3.1 shall read as follows:

In consideration, the City will reimburse Contractor for costs incurred in accordance with the budget approved by City Council of San Antonio in the above referenced Ordinance, and all subsequently authorized amendments to that budget. Said budget is affixed hereto and incorporated herein for all purposes as **Attachment II**. It is specifically agreed that reimbursement hereunder shall not exceed the total amount of **\$33,989.00**

3. Section 3.2 shall read as follows:

The funding level of this Contract is based on an allocation from the following funding sources:

<u>\$33,989.00</u> General Fund

Consequently, Contractor agrees to comply with the **Funding Guide**, affixed hereto and incorporated herein for all purposes as **Attachment III**.

4. Section 24.1(A) shall read as follows:

An increase in funding of this Contract in an amount not exceeding (a) twenty-five percent (25%) of the total amount of this Contract or (b) \$25,000.00, whichever is the lesser amount; provided, however, that the cumulative total of all amendments increasing funding and executed without City Council approval pursuant to this subsection during the term of this Contract shall not exceed the foregoing amount

- 5. The document attached hereto and incorporated herein as **Exhibit I** reflects agreed upon budget revisions to **Attachment II**, the budget for the Guadalupe Community Center Project. The revisions supersede prior conflicting or inconsistent agreements with regard to the referenced project budget, and all references in the Contract to the budget shall mean the budget as revised by this Amendment.
- 6. The document attached hereto and incorporated herein as **Exhibit II** reflects agreed upon revisions to **Attachment I**, the Scope of Work and SA2020 Scorecard, in the Contract. The revisions supersede prior conflicting or inconsistent agreements with regard to the referenced Scope of Work and SA 2020 Scorecard, and all references in the Contract to the Scope of Work and SA 2020 Scorecard shall mean the Attachment I as revised by this Amendment
- 7. All other terms, conditions, covenants and provisions of the Contract are hereby continued and shall remain in effect in their original form, except for the provisions modified by this Amendment.
