AN ORDINANCE

**AUTHORIZING THE SECOND AMENDMENT TO THE INTERLOCAL
AGREEMENT WITH VIA METROPOLITAN TRANSIT AUTHORITY
INCREASING THEIR CONTRIBUTION TO \$294,000.00 ANNUALLY
FOR PARTICIPATION IN THE DOWNTOWN PUBLIC IMPROVEMENT
DISTRICT THROUGH SEPTEMBER 30, 2023 AND INCREASING THE
NUMBER OF CLEANING AT CERTAIN BUS STOPS RECEIVING
SUPPLEMENTAL SERVICES.**

WHEREAS, pursuant to Ordinance Number 2013-05-30-0380, passed and approved on May 30, 2013, the City Council approved the re-establishment of the Downtown Public Improvement District ("PID") through September 30, 2023 pursuant to the Public Improvement District Assessment Act, Local Government Code, Chapter 372; and

WHEREAS, the PID is a means through which property owners in the District can self-fund additional improvements and services to enhance the appearance and safety of the San Antonio downtown area; and

WHEREAS, pursuant to Ordinance Number 2009-09-10-0695, passed and approved on September 30, 2009, and as amended by the First Amendment pursuant to Ordinance No. 2013-09-05-0614, passed and approved on September 5, 2013, the City Council approved an Interlocal Agreement with VIA Metropolitan Transit ("VIA") for VIA's participation in the PID; and

WHEREAS, it is now necessary to authorize the Second Amendment to the Interlocal Agreement with VIA increasing VIA's annual payment to \$294,000.00 and expanding the number of cleaning at certain bus stops receiving supplemental services; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council of the City of San Antonio hereby authorizes the City Manager or her designee to execute the Second Amendment to the Interlocal Agreement with VIA for participation in the Downtown Public Improvement District. A copy of the Second Amendment, previously executed by VIA, is set out in **Attachment I**.

SECTION 2. Funds generated by this Ordinance will be deposited into Fund 69018000, Internal Order 207000000122 and General Ledger 4101104.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS

Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall take effect immediately upon the receipt of eight affirmative votes; otherwise it shall be effective ten days after its passage.
