

AN ORDINANCE 2015-10-15-0874

AUTHORIZING THE CITY MANAGER TO ESTABLISH PARKING RATES FOR PILOT PARKING PROGRAMS FOR CUSTOMERS FOR UP TO 12 MONTHS; AND AMENDING THE AIRPORT RULES AND REGULATIONS SET OUT IN CHAPTER 3 OF THE CITY CODE TO PROVIDE FOR AIRPORT PARKING PROGRAMS.

* * * * *

WHEREAS, the City of San Antonio is the owner and operator of the San Antonio International Airport and Stinson Municipal Airport, and has authority to promulgate rules and regulations that promote the safe and efficient operation of the airports and to establish the rates and fees for the airport system; and

WHEREAS, the Aviation Department requests authority for the City Manager to establish parking rates for pilot parking programs at San Antonio International Airport for up to twelve months in order to evaluate the programs and their terms and conditions; and

WHEREAS, the pilot parking programs would commence the first day a customer uses the new service and would require City Council authorization in order to implement the program on a permanent basis after the expiration of the initial twelve month pilot program period; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager is hereby authorized to establish parking rates for pilot parking programs at the San Antonio International Airport for up to twelve months, commencing upon the first day a customer uses a new service.

SECTION 2. Chapter 3, Article II of the City Code of San Antonio, Texas, Section 3-179(6) is amended by replacing Section 3-179(6) in its entirety with the contents of the document set out in Attachment I to this Ordinance.

SECTION 3. Funds generated by this Ordinance shall be deposited into Fund 51001000, Internal Order 233000000009 and General Ledger 4405300.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall take effect immediately upon passage by eight (8) affirmative votes; otherwise it shall be effective ten (10) days after its passage.



Section. 3-179 – Parking rates and charges.

(6) ~~Premium p~~Parking programs. The ~~City Manager~~aviation department is hereby authorized to establish rates for implement a pilot premium parking programs and establish reserved parking area(s) for the program in public parking areas at San Antonio International Airport for passenger convenience. Upon completion of an initial 12 month pilot program, in order to implement the program on a permanent basis, City Council must approve each such program and its associated rates and charges. Fees are established as follows:

- ~~a. Annual registration fee. One hundred dollars (\$100.00).~~
- ~~b. Daily fee. Hourly parking area rate plus two dollars (\$2.00).~~

Section. 3-179 – Parking rates and charges.

(6) Parking programs. The City Manager is hereby authorized to establish rates for pilot parking programs in public parking areas at San Antonio International Airport for passenger convenience. Upon completion of an initial 12 month pilot program, in order to implement the program on a permanent basis, City Council must approve each such program and its associated rates and charges.
