

AN ORDINANCE 2014 - 05 - 15 - 0338

ADJUSTING THE SALARY OF THE CITY CLERK TO PROVIDE FOR A 5% PAY ADJUSTMENT IN ACCORDANCE WITH CITY COUNCIL'S EVALUATION OF THE CITY CLERK'S PERFORMANCE.

WHEREAS, City Council recently evaluated the performance of the City Clerk; and

WHEREAS, appropriations to provide pay adjustments for the City Clerk were included in the FY2014 Budget; and

WHEREAS, it is now necessary to provide for and approve a specific pay adjustment for the City Clerk; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Clerk shall receive a 5% pay adjustment based on the City Council evaluation of the City Clerk's performance.


SECTION 2. Funds are authorized to be transferred from the General Fund Non-Departmental Budget to the City Clerk's Office budget equivalent to the amount of the salary increase. The Director of Finance is authorized to perform the actions necessary to carry out the purpose and obligations of this Ordinance.

SECTION 3. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.


