

AN ORDINANCE 2017-09-14-0658

**AUTHORIZING A CONTRACT WITH FITNESS IN MOTION OF SOUTH TEXAS TO PROVIDE THE CITY'S DEPARTMENT OF HUMAN SERVICES WITH INCLUSIVE EXERCISE EQUIPMENT FOR SENIORS WITH DISABILITIES FOR TEN SENIOR CENTERS LOCATED THROUGHOUT THE CITY FOR A TOTAL COST OF \$121,260.00, FUNDED FROM THE DHS OPERATING BUDGET.**

**WHEREAS**, proposals were submitted to provide the City of San Antonio's Department of Human Services (DHS) with inclusive exercise equipment for seniors with disabilities for ten senior centers located throughout the city; and

**WHEREAS**, the equipment will augment existing equipment at each of the centers and consists of bikes, steppers, treadmills and rowers which provide easy accessibility by senior users; and

**WHEREAS**, five responsive proposals were received and evaluated; and

**WHEREAS**, the proposal submitted by Fitness in Motion of South Texas received the highest ranking and is recommended for award by the evaluation committee; **NOW THEREFORE**:

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The proposal submitted by Fitness in Motion of South Texas to provide the City with inclusive exercise equipment for seniors with disabilities for DHS senior centers for a total cost of \$121,260.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. Attached hereto and incorporated herein for all purposes as **Exhibit I** is the Score Summary. Copies of the proposals are available for inspection in the offices of the Purchasing Division of the Finance Department.

**SECTION 2.** The following fund, internal order and general ledger accounts are hereby designated for use in the accounting for the authorization of this contract with Fitness in Motion of South Texas for the purchase of inclusive exercise equipment in the total amount up to \$121,600.00.



**SECTION 3.** The sum of up to \$121,600.00 is hereby appropriated in the above designated fund and payment is authorized to Fitness in Motion of South Texas upon issuance of a purchase order.

**SECTION 4.** The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

**SECTION 5.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
