

AN ORDINANCE **2017-01-19-0016**

AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION IN THE AMOUNT OF \$65,000.00 BY THE CITY OF SAN ANTONIO, THROUGH THE CARVER COMMUNITY CULTURAL CENTER, TO S.C. JOHNSON GIVING FOR THE PURPOSE OF INCREASING THE CARVER'S MARKETING AND OUTREACH EFFORTS.

WHEREAS, S.C. Johnson is an American multinational privately held, manufacturer of household cleaning supplies and other consumer chemicals and the company's foundation, S.C. Johnson Giving supports organizations involved with arts and culture, education, the environment, health, social services, and community development; and

WHEREAS, the Carver Community Cultural Center ("Carver") is a multicultural and multi-disciplinary performing and visual arts center with an emphasis on the contributions of African and African-American artists and the Carver is always seeking to reach a greater audience that would appreciate the programming that the Carver brings to San Antonio; and


WHEREAS, if selected to receive these grant funds, the City intends to utilize the money to increase the Carver's marketing and outreach efforts; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. The submission of a \$65,000.00 grant application to S.C. Johnson Giving by the City of San Antonio, through the Carver, for the purpose of increasing the Carver's marketing and outreach efforts, is authorized and approved.

SECTION 2. This Ordinance shall take effect immediately upon the receipt of eight affirmative votes; otherwise it shall be effective ten days after its passage.


