

**AN ORDINANCE**

**AWARDING A CONSTRUCTION CONTRACT TO E-Z BEL CONSTRUCTION, LLC FOR THE CONSTRUCTION OF MEDICAL CENTER INTERSECTION IMPROVEMENT PHASE X, A 2017-2022 GENERAL OBLIGATION BOND FUNDED PROJECT LOCATED IN COUNCIL DISTRICT 8, IN AN AMOUNT NOT TO EXCEED \$4,610,951.39; OF WHICH FUNDS IN THE AMOUNT NOT-TO-EXCEED \$4,265,984.39 WILL BE FUNDED BY THE CITY; AND FUNDS IN THE AMOUNT NOT-TO-EXCEED \$344,967.00 WILL BE REIMBURSED BY SAN ANTONIO WATER SYSTEM.**

**WHEREAS**, this project is executed in cooperation with the Medical Center Alliance and is part of the Medical Center Intersection Improvements Project which is a multi-phase plan to facilitate traffic flow into and through the Medical Center by improving various high-volume intersections; and

**WHEREAS**, this project is to improve drainage and signal operations at the intersection of Floyd Curl and Louis Pasteur, adding a right turn lane on Louis Pasteur at Babcock intersection which also includes new curbs, sidewalks, driveways and traffic signals; and

**WHEREAS**, the City received five bids in response to an invitation for bid released in July 2017; and

**WHEREAS**, this Ordinance accepts the lowest responsive bid submitted by E-Z Bel Construction, LLC in the amount not to exceed \$4,610,951.39 for the construction of Medical Center Intersection Improvement Phase X, a 2017-2022 General Obligation Bond funded project located in Council District 8; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The lowest responsive bid by E-Z Bel Construction, LLC in the amount not to exceed \$4,610,951.39 for the construction of Medical Center Intersection Improvement Phase X, a 2017-2022 General Obligation Bond funded project located in Council District 8, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date hereof, whichever comes first.

**SECTION 2.** Funds are authorized to be **received from SAWS** to SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-01594, Medical Center Ph 10 (Ewing Halsell/Louis Pasteur), and the budget shall be revised by **increasing** WBS element 23-01594-90-08, SAWS Contribution and SAP General Ledger 4502280, Contribution from General Obligation Agencies, in the amount of \$344,967.00.

**SECTION 3.** The amount of \$344,967.00 is appropriated in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-01594, Medical Center Ph10(Ewing Halsell/Louis Pasteur., and the budget shall be revised by **increasing/decreasing** SAP WBS Elements as follows:

**SECTION 4.** A Payment in an amount not to exceed \$4,130,655.33 in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-01594, Medical Center Ph 10 (Ewing Halsell /Louis Pasteur), is authorized to be encumber made payable to **E-Z Bel Construction, LLC**, for construction services.

**SECTION 5.** A Payment in an amount not to exceed \$480,296.06 in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-01593, Medical Center (Louis Pasteur Dr. @ Babcock Rd Int.), is authorized to be encumber made payable to **E-Z Bel Construction, LLC**, for construction services.

**SECTION 6.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 7.** This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
