

AN ORDINANCE 2016-06-02-0388

ACCEPTING THE LOWEST RESPONSIVE BID AND AWARDING A CONSTRUCTION CONTRACT IN THE AMOUNT OF \$1,828,399.50 TO WINTERS CONSTRUCTION TO REPLACE THE CROCKETT STREET BRIDGE AS PART OF THE CITY-WIDE BRIDGE REPLACEMENT PROJECT, A 2012-2017 BON-FUNDED PROJECT LOCATED IN COUNCIL DISTRICT 2.

WHEREAS, the City-Wide Bridge Replacement Project is a \$23.4 million 2012 - 2017 Bond program funded Project intended to replace City owned bridge structures rated as deficient, either due to compromised structural integrity, insufficient drainage capacity, or inadequate traffic provisions, or a combination; and

WHEREAS, the Transportation and Capital Improvement Department initiated a bridge selection process to create a short-list of recommended bridges that need replacement, said process entailed an evaluation of the 2011 Texas Department of Transportation (TxDOT) San Antonio District Off-System Bridge list and TxDOT's National Bridge Inventory to help identify bridges with the greatest potential for improvement; and

WHEREAS, based on the evaluation of these lists, seven bridges were selected for the 2012 City-Wide Bridge Replacement Project: 1) Shaenfield Road Bridge, 2)Crockett Street Bridge, 3) Ashley Road Bridge, 4) Commerce Street Bridge, 5) South Laredo Street Bridge, 6) Bronco Drive Bridge, and 7) Dreamwood Drive Bridge; and

WHEREAS, the Crockett Street Bridge was selected due to its severe structural damage and load capacity rating for vehicular traffic; and

WHEREAS, this bridge, known as a lenticular pony truss was built in 1891, and this Project will rehabilitate the existing steel truss bridge crossing the San Antonio Riverwalk at Crockett Street, by removing the concrete slabs and sidewalks, repairing and replacing parts under bridge, and removing, modifying and repairing the rail; and

WHEREAS, construction activities will take place from 8 a.m. to 7 p.m. daily with no night work taking place and during the construction phase, Crockett Street will be closed and a detour route will be implemented to accommodate pedestrian and vehicular traffic; construction is anticipated to be completed by June 2017; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by **Winters Construction, Inc.** in the amount not to exceed \$1,828,399.50 for the replacement of the Crockett Street Bridge; and

WHEREAS, this is a one-time capital improvement expenditure in the amount of \$1,828,399.50 for which funds are available from the 2012-2017 General Obligation Bonds and are included in the FY 2016-2021 Capital Improvements Program Budget; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid of **Winters Construction, Inc.** in the amount of \$1,828,399.50 for the replacement of the Crockett Street Bridge as part of the City-Wide Bridge Replacement Project is hereby approved.

SECTION 2. Payment in the amount of \$1,828,399.50 in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00294, Citywide Bridge Program, is authorized to be encumbered and made payable to **Winters Construction, Inc.** for construction services.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


SECTION 4. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
