

AN ORDINANCE 2015-02-19-0108

ACCEPTING THE LOWEST RESPONSIVE BID AND AWARDING A CONSTRUCTION CONTRACT IN THE AMOUNT NOT TO EXCEED \$1,316,847.58 TO E-Z BEL CONSTRUCTION, LLC, FOR THE MUD CREEK TRIBUTARY A DRAINAGE, A 2012-2017 BOND-FUNDED PROJECT, LOCATED IN COUNCIL DISTRICT 10, AND OF THIS AMOUNT \$337,794.08 WILL BE REIMBURSED BY SAWS.

WHEREAS, 2012-2017 General Obligation Bond Program authorized \$2,000,000.00 for funding of the Mud Creek Tributary A Drainage Project; and

WHEREAS, the Mud Creek Tributary A Drainage Project extends from Thousand Oaks Drive to 1500 feet upstream of Mud Creek; and

WHEREAS, this Project provides for the improvement of the existing channel by tying to the existing concrete rip rap structure at Thousand Oaks and excavating the channel to accommodate more capacity within the creek and will improve the drainage and will remove 64 properties from the floodplain; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by **E-Z Bel Construction, LLC** in the amount not to exceed \$1,316,847.58 for the Mud Creek Tributary A Drainage Project, and

WHEREAS, of the total contract amount, the City will be reimbursed \$337,794.08 by San Antonio Water Systems; **NOW THEREFORE,**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The lowest responsive bid of **E-Z Bel Construction, LLC** in the amount not to exceed \$1,316,847.58 for the Mud Creek Tributary A Drainage Project is hereby accepted. All other bids will be considered rejected upon the execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date hereof, whichever occurs first.

**SECTION 2.** A construction contract is hereby awarded to **E-Z Bel Construction, LLC**.


**SECTION 3.** The following financial adjustments are hereby approved:

- a) Funds are authorized to be received from SAWS to SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00330, Mud Creek Tributary A Drainage, and the budget shall be revised by increasing WBS element 40-00330-90-08, SAWS Contribution and SAP General Ledger 4502280, Contribution from other Agencies, in the amount of \$337,794.08.

- b) The amount of \$81,650.07 is appropriated in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00330, Mud Creek Tributary A Drainage, SAP WBS Element 40-00330-05-02-03, Construction-SAWS Sewer and SAP General Ledger 5201245.
- c) The amount of \$256,144.01 is appropriated in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00330, Mud Creek Tributary A Drainage, SAP WBS Element 40-00330-05-02-04, Construction-SAWS Water and SAP General Ledger 5201245.
- d) Payment in the amount of \$1,316,847.58 in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00330, Mud Creek Tributary A Drainage, is authorized to be encumbered and made payable to **E-Z Bel Construction, LLC.**, for construction services. Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved operating and/or capital budgets for current and future fiscal years.
- e) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
