ORDINANCE

APPROVING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$1,868,000.00, FUNDED FROM THE DEPARTMENTS' FY 2019 ADOPTED OPERATING BUDGETS: (A) CELLISCO DBA ACCU-PRINT, LOPEZ PRINT & MARKETING, LLC, RUSH AMERICAN PRINTING, INC., AND SMITH PRINT FOR SUPPLEMENTAL PRINTING SERVICES; (B) VERMEER TEXAS – LOUISIANA FOR VERMEER EQUIPMENT PARTS & REPAIR SERVICES; (C) CATO ELECTRIC COMPANY FOR DRILLING WOOD & STEEL POLE FOUNDATIONS; (D) MERGENT, INC. FOR MERGENT DATABASE SUBSCRIPTIONS; AND (E) T & W TIRE, L.L.C. FOR TIRES FOR EMERGENCY VEHICLES.

WHEREAS, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

WHEREAS, this ordinance approves the following contracts: (A) Cellisco dba Accu-Print, Lopez Print & Marketing, LLC, Rush American Printing, Inc., and Smith Print for supplemental printing services; (B) Vermeer Texas - Louisiana for Vermeer equipment parts and repair services; (C) CATO Electric Company for drilling wood and steel pole foundations; (D) Mergent, Inc. for Mergent database subscriptions; and (E) T & W Tire, L.L.C. for emergency tires; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(7)(A), which provides for any items that are available only from a sole source of supply; and

WHEREAS, the Texas Local Government Code section 271.102 provides for the City's participation in cooperative purchasing programs and such purchases satisfy any state law requiring competitive bidding; and

WHEREAS, this ordinance approves six low bid contracts, one sole source contract, and a cooperative purchase; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following bids to furnish the City with goods and services on an annual basis as shown on the attached bid tabulation sheets are hereby accepted, subject to and contingent

upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements: (A) Cellisco dba Accu-Print, Lopez Print & Marketing, LLC, Rush American Printing, Inc., and Smith Print for supplemental printing services; (B) Vermeer Texas - Louisiana for Vermeer equipment parts and repair services; (C) CATO Electric Company for drilling wood and steel pole foundations; (D) Mergent, Inc. for Mergent database subscriptions; and (E) T & W Tire, L.L.C. for tires for emergency vehicles. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

SECTION 2. Funds will be encumbered upon issuance of purchase orders, and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2019 budget, and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

SECTION 3. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
