AN ORDINANCE

AMENDING THE TRAFFIC CONTROL DEVICES SCHEDULES ESTABLISHED BY CHAPTER 19 (TRAFFIC REGULATIONS), ARTICLE III (TRAFFIC CONTROL DEVICES), SECTION 19-68(B) TO INCLUDE CERTAIN ADDITIONS TO THE OFFICIAL TRAFFIC-CONTROL DEVICE SCHEDULE FOR "FULL TRAFFIC SIGNAL LOCATIONS", "ONE-WAY 7 A.M. TO 9 A.M. AND 2 P.M. TO 4 P.M. SCHOOL DAYS ONLY" SIGNS, "ALL WAY STOPS" SIGNS " CROSS STREET STOP" SIGNS, "MAXIMUM SPEED LIMIT" SIGNS, "PARKING PROHIBITED AT ALL TIMES, INCLUDING SUNDAYS AND HOLIDAYS" SIGNS, "STOPPING, STANDING, OR PARKING PROHIBITED 7 AM TO 9 AM AND 2 PM TO 4 PM SCHOOL DAYS ONLY" SIGNS "SCHOOL ZONES, SCHOOL CROSSWALKS (MID-BLOCK)7:00 A.M.TO 9:00 A.M. 2:00 P.M. TO 4:00 P.M. TWENTY MILES PER HOUR, SCHOOL DAYS ONLY AND CELL PHONE USE PROHIBITED" SIGNS, "SCHOOL ZONES, SCHOOL CROSSWALKS (INTERSECTION) 7:00 A.M.TO 9:00 A.M. 2:00 P.M. TO 4:00 P.M. TWENTY MILES PER HOUR, SCHOOL DAYS ONLY AND CELL PHONE USE PROHIBITED" SIGNS, "SCHOOL CROSSWALK (INTERSECTIONS), 7:00 A.M. TO 9:00 A.M AND 2:00 P.M. TO 4:00 P.M., SPECIFIED SPEED, SCHOOL DAYS ONLY AND CELL PHONE USE PROHIBITED" SIGNS, "SCHOOL CROSSWALK (MID-BLOCK), FLASHING BEACON, SPECIFIED SPEED AND CELL PHONE USE PROHIBITED" SIGNS, "SCHOOL CROSSWALK (INTERSECTION), FLASHING BEACON, SPECIFIED SPEED" SIGNS AND "SCHOOL CROSSWALK (INTERSECTION), 7:00 A.M. TO 9:00 A.M. AND 2:00 P.M. TO 5:00 P.M., SPECIFIED SPEED, SCHOOL DAYS ONLY AND CELL PHONE USE PROHIBITED" SIGNS AND "STUDENT LOADING ZONE, 7 A.M. TO 9 A.M. AND 2 P.M. TO 4 P.M. SCHOOL DAYS ONLY" SIGNS; AUTHORIZING THE PERMANENT INSTALLATION OF SAID DEVICES; DECLARING THEM AS OFFICIAL TRAFFIC CONTROL DEVICES OF THE CITY OF SAN ANTONIO; AND DECLARING VIOLATIONS OF THESE TRAFFIC REGULATIONS, EXCEPT THE CIVIL PARKING VIOLATIONS, TO BE MISDEMEANOR CRIMES PUNISHABLE BY A FINE OF NOT MORE THAN \$200.00, AND DECLARING VIOLATIONS OF THE CIVIL PARKING VIOLATIONS TO BE SUBJECT TO THE ENFORCEMENT PROVISIONS OF CITY CODE SECTION 19-225(ADMINISTRATIVE ADJUDICATION OF STOPPING, STANDING AND PARKING VIOLATIONS), AND ESTABLISHING AN EFFECTIVE DATE OF NO MORE THAN 5 DAYS AFTER PUBLICATION IN ACCORDANCE WITH ARTICLE 2, SECTION 17, OF THE CITY CHARTER.

WHEREAS, Chapter 19 of the City Code requires that all official traffic controls, devices, and regulations be established by separate ordinances; and

WHEREAS, there are certain traffic control devices, parking regulations, and other traffic control regulations at certain locations that have been surveyed by traffic engineers, and determined to be necessary for the public safety; and

WHEREAS, Section 19-68 of the traffic regulations in the City Code require that schedules of the various traffic control devices be maintained and kept updated at the Office of the City Clerk; and

WHEREAS, parking regulations are enforced through civil penalties, while all other traffic violations are misdemeanor crimes; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Traffic Control Device Schedules enacted through Section 19-68(b) of the City Code of the City of San Antonio are hereby amended and the city clerk is hereby authorized to:

SECTION 2. All traffic control signs, signals, and other devices listed herein are hereby declared to be official traffic control devices of the City of San Antonio. A violation of any traffic control device or regulation established herein are hereby declared to be Class "C" misdemeanor crimes, and shall be punished by a fine of not less than \$1.00 nor more than \$200.00.

SECTION 3. This ordinance shall become effective on the fifth day after publication in accordance with Article 2, Section 17, of the City Charter but in no manner less than the tenth day after passage by the City Council.
