

**INTEGRATION AGREEMENT FOR ANNUAL CONTRACT
FOR SUPPLEMENTAL EVENT SECURITY SERVICES**

**REQUEST FOR COMPETITIVE SEALED PROPOSAL (“RFCSP”) NO.: 6100009611
RFCSP 17-110**

This Agreement is entered into by and between the City of San Antonio, Texas, a home-rule municipal corporation (City), by and through its Director of Finance or said Director’s designee, and Staff Pro, Inc. (Vendor), both of which may be referred to herein collectively as the “Parties”.

The Parties hereto severally and collectively agree, and by the execution hereof are bound, to the mutual obligations herein contained and to the performance and accomplishment of the tasks hereinafter described.

1.0 CONTRACT DOCUMENTS

The terms and conditions for performance and payment of compensation for this Agreement are set forth in the following contract documents, true and correct copies of which are attached hereto and fully incorporated herein for all purposes, and shall be interpreted in the order of priority as appears below:

- 1.2 City’s RFCSP No.: 6100009611 / 17-110, including all attachments and addenda thereto;
- 1.3 Vendor’s proposal in response to City’s RFCSP No.: 6100009611 / 17-110, including all Best and Final Offers and clarifications thereto.

2.0 PRICING

Parties agree that pricing for this contract shall be in accordance with Vendor’s response to Best and Final Offer, Attachment B, Price Schedule –Dated 5/08/18.

3.0 RENEWALS.

Parties agree that City shall have the right to renew this contract on the same terms and conditions for 2 additional one year periods. Said renewals shall be in writing, signed by Director, and shall not require City Council approval, subject to and contingent upon appropriation of funding therefore.

4.0 ENTIRE AGREEMENT

Staff Pro, Inc. hereby concurs that all negotiations have been concluded, and that these contract documents represent the final agreement of both Parties. This Agreement, together with its attachments and exhibits, if any, constitutes the final and entire agreement between the parties hereto and contains all of the terms and conditions agreed upon. No other agreements, oral or otherwise, regarding the subject matter of this Agreement shall be deemed to exist or to bind the parties hereto, unless the same are in writing, dated subsequent to the date hereto, and duly executed by the parties.
