

AN ORDINANCE 2014 - 09 - 18 - 0694

ESTABLISHING NEW FEES AND AMENDING FEES AS INCLUDED WITHIN THE FISCAL YEAR 2015 BUDGET WITHIN THE GENERAL FUND AND WITHIN THE RESTRICTED FUNDS OF AIRPORT OPERATING AND MAINTENANCE; CONVENTION AND SPORTS FACILITIES; CONVENTION AND VISITORS BUREAU; PARKING OPERATING AND MAINTENANCE; AND SOLID WASTE OPERATING AND MAINTENANCE; AND AMENDING THE CITY CODE OF SAN ANTONIO, TEXAS (CITY CODE) TO REFLECT SUCH CHANGES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Fees. Fees within the General Fund and within the Restricted Funds of Airport Operating and Maintenance, Convention and Sports Facilities, Convention and Visitors Bureau, Parking Operating and Maintenance, and Solid Waste Operating and Maintenance are hereby established and/or amended as provided for in Attachments A through N, inclusive, as follows:

SECTION 3. Severability. SECTION 5. Effective Date. Unless specifically provided for otherwise, this Ordinance shall take effect October 1, 2014.



Section 1. Vital Records - Certified Mail Fees. A Shipping & Handling Fee for Standard Certified Mail with Receipt Requested is established at \$11.20 to recover the costs to mail vital records via certified mail. An Overnight Certified Mail with Receipt Requested fee is established at \$24.25 to recover the costs of sending vital records via certified mail overnight.

FIRE DEPARTMENT

SECTION 1. EMS Fees. Subsection 15-3(a) of the City Code of San Antonio, Texas is hereby amended, in its entirety, as follows:

The fee for the transportation (transport) of patients requiring basic life support emergency medical services is \$950.00 per patient plus \$12.00 per mile. The fee for the transportation (transport) of patients requiring advanced life support level I emergency medical services is \$950.00 per patient plus \$12.00 per mile. The fee for the transportation (transport) of patients requiring advanced life support level II emergency medical services is \$950.00 per patient plus \$12.00 per mile. In addition to the transportation fee, a surcharge of \$100.00 is assessed to each nonresident patient who is transported for emergency medical services. A nonresident is any person who does not permanently reside within the territorial limits of the city or who resides within the territorial limits of an adjoining incorporated city which does not have a contract with the city to provide emergency medical services.

SECTION 2. Full Force and Effect. All other provisions of the City Code of San Antonio, Texas shall remain in full force and effect, unless expressly amended by other provisions of this Ordinance.

HEALTH DEPARTMENT

SECTION 1. Health Services fees, including private insurance billing. The dental clinic fee, the Quantiferon testing fee and the Legionella culture testing fee are hereby eliminated. The City Code, Section 15-2, is amended to read as indicated below. Additions are underlined and deletions are ~~struck through~~.

Sec. 15-2. Fees for services from health department.

(a) In cases ~~where individuals are of appropriate~~ covered by Medicaid or private insurance, ~~Dental Services the city's city STD, Tuberculosis and Immunization dental clinics clinic fees will bill Medicaid or the individual's private insurance company for clinic fees at the applicable equal the community's prevailing Medicaid or private insurance company's reimbursement rate. Individuals not covered by Medicaid, private insurance or a qualified immunization program. Fees may will be assessed fees~~ on a sliding scale based on the patient's family income. ~~In addition to the sliding fee scale all patients will be required to pay a ten dollar (\$10.00) appointment fee.~~ No patient otherwise qualified to receive ~~dental~~ health clinic services will be denied said services based on an ability to pay the established fee.

(b) Individuals not covered by the provisions in subsection (a) who receive vaccinations from the health department will reimburse the health department based on the current fee schedule of the vaccine used, plus all applicable administrative fees.

(c) All individuals, organizations and and/or businesses, including foster homes, requesting health department inspections for any type of facility or establishment not currently regulated or licensed elsewhere in this Code shall pay a forty-five dollar (\$45.00) fee for the initial inspection. Correction of violation(s) is to be verified by the health department after receiving written notification from the permit holder that the violations have been eliminated or at the end of the specified period of time and be noted on the inspection report and in the health department's records. All fees shall be paid before the inspections are performed. Fees collected under this section shall be deposited into the city general fund.

(d) Non-food or environmental re-inspections, which shall include but not be limited to the re-inspection of swimming pools and spas, day care facilities, foster homes, hotels/motels, rendering, smoking violations, air pollution sources, and mobile living parks, are established as follows:

Cost of reinspection shall be:

First reinspection\$45.00
Second reinspection75.00
Third reinspection100.00
Fourth reinspection120.00

~~(e) The fee charged by the health department for Quantiferon testing is hereby established at thirty dollars (\$30.00).~~

~~(f) The fee charged by the health department for Legionella Culture testing is hereby established at one hundred dollars (\$100.00).~~

~~(e) (g)~~ The administrative service fee charged by the health department for all office visits for non Medicaid patients is hereby established at fifteen dollars (\$15.00).

~~(f) (h)~~ A fee of two dollars (\$2.00) is hereby established for a protective cover for birth and death certificates.

~~(i) The fee charged by the health department for T-Spot.®TB ELISPOT interferon gamma releasing assay (IGRA) for Tuberculosis testing is hereby established at sixty nine dollars (\$69.00).~~

~~(j) Veterinarian clinics located outside of the city limits shall be charged a rabies testing fee of forty dollars (\$40.00) per test by the health department.~~

SECTION 2. Water testing and other Health Laboratory Fees. The City Code, Section 15-4, is hereby amended to read as indicated below. Additions are underlined and deletions are ~~struck through~~.

Sec. 15-4. Health department laboratory fees. Fee for water bacteriology test.

~~(a) A fee in the amount of twenty five dollars (\$25.00) (\$20.00) per test is hereby established for all persons requesting a water bacteriology test from the health department laboratory. except water purveyors submitting twenty five (25) to fifty (50) samples for testing at one time will be charged twelve dollars and fifty cents (\$12.50) per test and water purveyors submitting greater than fifty (50) tests at one time will be charged ten dollars (\$10.00) per test. No fee will be required for water bacteriology tests performed for units of state or local health departments so long as the health department laboratory is classified as a regional contract laboratory by the state department of health.~~

~~(b) The fee charged by the health department for T-Spot.®TB ELISPOT interferon gamma releasing assay (IGRA) for Tuberculosis testing is hereby established at sixty-nine dollars (\$69.00).~~

~~(c) Veterinarian clinics located outside of the city limits shall be charged a rabies testing fee of forty dollars (\$40.00) per test by the health department.~~

~~(d) The following schedule of testing fees are hereby established to be paid to the health department by private medical providers and private laboratories:~~

Sec. 22-17. Park usage fee for special events.

- a. Attendance four hundred (400) or less: Four hundred fifty dollars (\$450.00).
- b. Attendance four hundred one (401) to one thousand (1,000): Seven hundred fifty dollars (\$750.00).
- c. Attendance one thousand one (1,001) or more: One thousand one hundred dollars (\$1,100.00).

(3) Non-profit organization rental rate:

- a. Attendance four hundred (400) or less: Three hundred fifty dollars (\$350.00).
- b. Attendance four hundred one (401) to one thousand (1,000): Six hundred dollars (\$600.00).
- c. Attendance one thousand and one (1,001) or more: Nine hundred dollars (\$900.00).

SECTION 3. Full Force and Effect. All other provisions of the City Code shall remain in full force and effect, unless expressly amended by this Attachment or other provisions of this Ordinance.

SECTION 1. Record Fees. Section 25-6 of the City Code of San Antonio, Texas is hereby amended, in its entirety, as follows:

~~(a) The police department is authorized to charge a fee of two dollars (\$2.00) for each search of the traffic accident report files, or other record search not otherwise specifically covered in this section.~~

~~(1) No search fee will be charged in those instances wherein a copy of the accident report is purchased.~~

~~(b) The police department is authorized to charge a fee of three dollars (\$3.00) for each offense report, whether or not microfilmed.~~

~~(c) The police department is authorized to charge a fee of two dollars (\$2.00) for each assignment report.~~

~~(ad) The police department is hereby authorized to charge the following fees listed below in connection with records of arrests the following services:~~

~~(1) A fee of ten dollars (\$10.00) shall be charged for an arrest record letter.~~

~~(2) A fee of ten dollars (\$10.00) shall be charged for a clearance letter.~~

~~(3) A fee of ten dollars (\$10.00) shall be charged for a visa letter.~~

~~(4) A fee of five dollars (\$5.00) shall be charged for notarization or certification of an arrest record letter, a clearance letter, or a visa letter.~~

~~(5) A fee of one dollar (\$1.00) shall be charged to the city housing authority for an arrest record it is authorized by law to receive.~~

~~(e) The police department is authorized to charge a fee of six dollars (\$6.00) for each traffic accident report and is authorized to charge an additional fee of two dollars (\$2.00) to certify each traffic accident report.~~

~~(f) The police department is authorized to charge a fee of eight dollars (\$8.00) for a single address police call survey, or similar survey.~~

~~(bg) The police department is hereby authorized to charge a fee of ten dollars (\$10.00) for any fingerprint work performed. Each fingerprint card will be charged at the rate of ten dollars (\$10.00) each.~~

(~~ch~~) All charges collected and received for the services provided herein shall be accounted for and handled in accordance with instructions issued by the city director of finance.

(~~i~~) ~~The police department is authorized to charge a fee of two dollars (\$2.00) to inspect each report in excess of three (3) reports during any single day.~~

(~~dj~~) The police department is authorized to charge an application processing fee of twenty-five dollars (\$25.00) for the processing of criminal history reviews of applicants who have submitted applications to the city.

SECTION 2. Full Force and Effect. All other provisions of the City Code of San Antonio, Texas shall remain in full force and effect, unless expressly amended by other provisions of this Ordinance.

Chapter 14, Section 14-30 entitled “Fees”, is hereby amended as follows:

Sec. 14-30. - Fees.

(a) *Residences.* Use of city garbage, brush, and refuse collection and removal and disposal services and payment of fees set out below for such services shall be mandatory except as exempted in subsection (d) below. The monthly fees for household garbage that includes recycling, brush, leaves and refuse collection shall be as follows:
